Other Matters

Returning Officer actions required (Section 193): Yes Details:

- The rules of the Organisation are silent about the nomination lodgement method. The Returning
 Officer applied subparagraph 193(1) (b)(ii) of the Act and allowed submission of nomination by
 email or AEC portal.
- As there was no rule pertaining to the withdrawal of Nomination, the Returning Officer applied subparagraph 193(1) (b)(ii) of the Act to fix a closing time for the withdrawal of the nomination and the withdrawal period was aligned with the close of the nomination period.
- Rules of the Organisation state that ballot to open within 14 days of close of the nomination. The Returning Officer deems that this time frame is not sufficient to ensure that no irregularities occur when checking the eligibility of nominations received and to ensure the documents for the ballot are correct. The Returning Officer applied subparagraph 193(1) (b)(ii) of the Act to extend the period considering eligibility check and defect period. Therefore, opened the ballot within 4 weeks of the close of the nomination instead of 14 days.
- Rules of the Organisation state that the maximum ballot period will not be more than 14 days.
 The Returning Officer applied subparagraph 193(1) (b)(ii) of the Act to extend the period due to current delivery time taken by Australia post and allowed at least 4 weeks instead of 14 days.

Arrangement for conduct of election.

[1] On 6 July and 22 July 2021 the Australian Hotels Association - Queensland Branch (the Branch) lodged with the Registered Organisations Commission prescribed information for an election to fill the following offices:

- [2] I note that, in relation to Zone General Committees and representatives elected to them (which have been elected on an annual basis), these were the subject of an election decision, [2020] ROCD 157, issued on 25 September 2020 in matter **E2020/121** arranging for an election for those particular offices.
- [3] However, as a result of the delay in the conduct of most industrial elections by the Australian Electoral Commission (AEC), arising from the COVID-19 pandemic and associated restrictions, election E2020/121 was among the elections delayed. Perusal of the AEC's 'List of current industrial elections', has confirmed that election E2020/121 is among those which are currently in the process of being conducted by the AEC.
- [4] All of the Zone offices that were the subject of the Delegate's decision in **E2020/121** were included in the prescribed information and amended prescribed information lodged in July 2021 in this current matter (**E2021/113**). (Prescribed information for the election of State Board Delegates and State Board Officers was included in the 2021 prescribed information but not in

the 2020 prescribed information, as an election for State Board roles is only scheduled to occur every second year, in accordance with the Branch rules, and is due for election in 2021).

- [5] With election E2020/121 currently underway, there is the potential for the two elections, E2020/121 and E2021/113 to occur simultaneously or in close temporal proximity to each other, in circumstances where some (but not all) of the offices for which prescribed information lodged for E2021/113, are already the subject of election in E2020/121.
- [6] Having reviewed the materials and taken into consideration that an election (E2020/121) is already underway in relation to various Zone offices, I do not propose to require the AEC to conduct two elections for those Zone offices.
- [7] In considering the effect of the delayed conduct of the election for Zone offices, which the Branch's rules (notably subrule 50(f) and subrule 52(b)) deal with, I request that the Branch consider the possible utility of amending its rules to align the timing of future scheduled elections for those offices.
- [8] As part of the Commission's function of providing advice and assistance to registered organisations, I propose to separately engage with the Branch to discuss means by which this issue may be able to be addressed before the next scheduled election is due.
- [9] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the Branch and, under subsection 189(3) of the Fair Work (Registered Organisations) Act 2009.
- [10] However, in circumstances where the Zone Committee officers and the Zone Committee representatives are the subject of an election process currently underway by the AEC in matter E2020/121, a duplicate election for those specific offices is not required. An election is still required for the offices of State Board Delegates and State Board office-bearers.
- [11] Proceeding on the basis that the AEC will complete the election process currently in train for the offices in the decision in **E2020/121** (i.e. the Zone officers and committee representatives), the AEC would then only need to undertake an election for the offices of State Board Delegates and State Board office-bearers for this current matter **E2021/113**.
