Other Matters

Extra Ordinary Vacancy election issue:

In regard to the Extraordinary Vacancy, Rule 19A of the Association states that should there be a vacancy in an office of Councillor (which was conducted in stage 1) by reason of the failure of the members of a Division to nominate or elect a councillor in accordance with the provisions of Rule 15 then the Council shall have power to elect a person to fill the vacant office from among the financial members of the Association who are not Councillors. The organisation explained to the Returning Officer that the Council generally does it after the completion of the collegiate (stage 2) election of the Officers conducted by AEC at the attendance ballot. The financial members are invited to submit nominations for vacant Councillor positions irrespective of the divisions they are attached to and if elected, financial members are allocated to vacant Councillor positions of different divisions by the Council.

However, when AEC conducts any election, AEC tends to complete the entirety of the election. Therefore, it is suggested that nominations for the vacant positions to be recalled by the AEC for the unfilled positions and members attached to any particular division should only be qualified to be elected for the divisions they are attached to.

Returning Officer actions required (Section 193): Yes

Details: The matters in which I have exercised the authority given to me by s.193 of the Act are:

- Rule of the Organisation states that the nomination to be closed 10 days after the circular of the election notice. As the election was conducted by post instead of attendance, the Returning Officer applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to varied the timing of the nomination period.

- As there is no rule pertaining to the withdrawal of Nomination, the Returning Officer applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to fix a closing time for the withdrawal of nomination and the withdrawal period was closed 4 days after the close of the nomination to allow nominees to withdraw nomination as the election procedure cannot be conducted by attendance due to Covid-19 issue.
- Rule of the Organisation states that ballot to open within 14 days after the close of nomination. The Returning Officer deemed that this time frame was not sufficient. The Returning Officer applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to extend the period considering eligibility check and defect period and opened the ballot within 28 days of the close of the nomination instead of 14 days.
- Rule of the Organisation states that the ballot to be closed within 10 days of the posting of ballot materials. As the timing of the election was affected by the Covid-19, the Returning Officer applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to vary the timing of the closing of the ballot period and ballot was closed within 28 days from the opening of the ballot.
- In spite of the rules of the organisation, nominations were to be lodged via email/ AEC portal to ensure that no irregularities occur as a result of the restrictions imposed by the Coronavirus pandemic and current Australia Post delivery times.
- Rules regarding the timetable of the election were set aside as the AEC held concerns that the coronavirus pandemic may impact on the ability for stakeholders to fully participate in the election. A timetable for the conduct of the ballot which varied from the rules was set when the AEC was satisfied that stakeholders would be able to fully participate.


