RE: LODGEMENT OF PRESCRIBED INFORMATION FOR ELECTION

Australian Business Industrial (ABI) is a registered organisation under the *Fair Work (Registered Organisations) Act 2009* (FW(RO) Act), organisation code 143N. ABI is seeking to conduct an election in accordance with the Rules of ABI most recently amended on 22 July 2019 (Rules), and the FW(RO) Act, and formally requests that the Registered Organisations Commission (ROC) arrange for the election to be conducted.

Composition of ABI Council

Under Rule 26 of the Rules, ABI is required to elect a Council which shall be the Committee of management and shall comprise fifteen (15) eligible members of ABI elected as provided by the Rules. These members are to be directly elected by and from the membership of ABI.

The declaration of the newly elected Council establishes an electoral college, under Rule 46, from which are elected the following formal office bearers:

- a) President,
- b) two Vice-Presidents,
- c) the Secretary-Treasurer (Rule 48) and;
- d) an additional three executive committee members (Rule 49),

Rule 28 of the Rules dictates that the Council shall be elected by a secret postal ballot.

ABI requests that you arrange for the conduct of both the general (direct) election of Councillors from the membership and the subsequent election of office bearers and executive committee members from the electoral college.

ABI does not comprise branches and as such regulation 138(1)(d) does not apply.

Timing of the Election

We wish to draw ROC's attention to the fact that ABI's election was previously planned to be completed on around July 2020 to comply with Rule 29. With the unprecedented intervention of COVID-19, and the fact that the AEC wrote to registered organisations and indicated they would not be conducting industrial elections for three months from 24 March 2020, ABI was unable to conduct its election as planned.

On 22 April 2020, ABI reached out to ROC to seek assistance with next steps in the Election process. ABI put forward two, somewhat interrelated, solutions:

Moving the Election

ABI Rule 29 confers an express discretion on ABI's Council to move the election process if the 'Council determines otherwise'. In light of this provision, ABI were of the view that the interests of ABI and its stakeholders is for Council to determine and adopt a revised timetable that move's the election to a date later in the year to ensure the integrity of, and the maximum participation by stakeholders in, the Election.

Holding Over

In the alternative, ABI sought ROC's view as to whether the doctrine of 'Holding Over' could apply to ABI.

Rule 28 - 'Election of Council' states that:

(b) At Quadrennial Elections all the members of the existing Council shall be deemed to have retired at the time that all fifteen (15) Eligible Members have been declared elected to the new Council by the Returning Officer;

(c) The term of the new Council commences at the time that all fifteen (15) Eligible Members have been declared elected by the Returning Officer.

The ABI rules do not state an explicit time limit on a Councillor's term. Rather, a Councillor's term comes to an end when the new the Returning Officer declares that 15 eligible members have been elected. On that basis, the Council could continue to govern ABI until the AEC is able to conduct elections again in the near future.

On 27 May 2020, Dean Tyler, Senior Associate at Australian Business Lawyers & Advisors, received a call from MaryAnne Guina from ROC in response to the correspondence of 22 April 2020.

Ms Guina advised that she agreed with the approach in the 22 April correspondence and that the current ABI Council could continue in its term until a new Council is elected.

In terms of a path forward, Ms Guina indicated ABI must hold and complete the Election process by 31 December 2020 to ensure compliance with the ABI Rules.

It is based on the above that ABI notifies ROC it is now seeking to conduct its Election.

Please accept the following as the prescribed information ABI is required to provide under s 189(1) of the FW(RO) Act and in accordance with regulation 138 of the *Fair Work (Registered Organisations) Regulations 2009.* We also attach a paper from ABI Council's most recent -meeting where the Council voted to conduct the Election in accordance with the timetable set out Attachment A of that paper.
