DECISION

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Police Federation of Australia

(E2020/15)

MR ENRIGHT

MELBOURNE, 6 MARCH 2020

Arrangement for conduct of election.

[1] On 21 January 2020 the Queensland Police Branch (the Branch) of the Police Federation of Australia lodged with the Registered Organisations Commission (ROC) a request for an election under section 187 of the Fair Work (Registered Organisations) Act 2009 (the RO Act), in terms which I acknowledge are consistent with the previous election request in E2015/279, for the following position:

Branch Secretary

- [2] Having now had the opportunity to carefully review this request, I note it is clear from correspondence exchanges that the Branch does not consider its Branch Secretary to be an 'office' as that word is defined in section 9(1)(a) of the RO Act. If its Branch Secretary were to be an office so defined, it would not be necessary for me to be determine whether the Branch has complied with section 187 of the RO Act in determining that an election is required in accordance with section 189.
- [3] In my view, a plain reading of section 9(1)(a) of the RO Act raises doubt about whether a person holding the title of 'Branch Secretary' can hold a non-office position.
- [4] To illustrate that point, the RO Act provides as follows:

9 Meaning of office

- (1) In this Act, office, in relation to an organisation or a branch of an organisation means:
 - (a) An office of president, vice president, secretary or assistant secretary of the organisation or branch; or
 - (b) ...
- [5] I consider the objectives of the RO Act concerning the efficient management of organisations to be important, I am satisfied that the term of office for this position is due to expire in the normal course of events and that an election to fill this position is due. If contrary to the above the Branch Secretary is not an office, I am satisfied for the purposes of s 189(3)(c) that the Branch has complied with s 187 in this case.

- [6] Being satisfied that an election for the abovenamed non-office is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act* 2009, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
- [7] However, I would urge the Police Federation of Australia to consider making alterations to the Branch rules which clarify whether the Branch Secretary (and accordingly the Branch Assistant Secretary) are persons holding an 'office' in accordance with section 9(1)(a) of the RO Act and I would encourage the organisation to continue its engagement with the ROC to resolve and clarify that issue.
