PRESCRIBED INFORMATION FOR ELECTIONS in accordance with Section 189 Fair Work (Registered Organisations) Act 2009 and Regulation 138 Fair Work (Registered Organisations) Regulations 2009

I am an officer of the Tasmanian Branch of the Police Federation of Australia and am authorised to sign this statement, which is prescribed for elections lodged in accordance with subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009. I request that you arrange elections with regard to the following information provided.

1. Elections are required for the following positions: Northern Sub-branch delegate, Western Sub-branch delegate, Southern Sub-branch delegate, Eastern Sub-branch delegate (2 positions), Officers Sub-branch delegate (2 positions).
2. The reason for the elections is that the incumbents of the positions: Alison Mackay (Northern Sub-branch delegate); William Flynn (Western Sub-branch delegate); Bruce Henderson (Southern Sub-branch delegate); Damien McVilly (Eastern Sub-branch delegate) have resigned their positions. Eastern Sub-branch delegate (1 position) no nominees received E2019/190, E2020/173, Officers Sub-branch delegate (2 positions) no nominees received E2019/190. (refer to rule 52BU(6)).
3. The electorate for the Northern Sub-branch delegate is the Northern Sub-branch. The electorate for the Western Sub-branch delegate is the Western Sub-branch. The electorate for the Southern Sub-branch delegate is the Southern Sub-branch. The electorate for the Eastern Sub-branch delegates is the Eastern Sub-branch. The electorate for the Officers Sub-branch delegate is the Officers Sub-branch.
4. The date requested for nominations to close is at a date to be determined by the Returning Officer (Rules 52BF(15) and 52BU(7)).

5. The date the roll of voters will close is at a date to be determined by the Returning Officer which will be 7 days before the day nominations are declared open (rules 52BF(17) & 52BF(1) for office bearers and trustees and rule 52BU(4) for the sub-branch position).
6. The voting system that we request be employed is the direct voting system.

This is confirmation there are no rule alterations/changes before Fair Work that will impact the election we have requested.
