**PRESCRIBED INFORMATION FOR ELECTIONS in accordance with Section 189 Fair Work (Registered Organisations) Act 2009 and Regulation 138 Fair Work (Registered Organisations) Regulations 2009**

I am an officer of the Tasmanian Branch of the Police Federation of Australia and am authorised to sign this statement, which is prescribed for an election lodged in accordance with subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009. I request that you arrange elections with regard to the following information provided.

1. Elections are required for the positions of Branch:
  - President
  - Vice President
  - Deputy Vice President
  - Treasurer
  - Trustees (3 positions)
2. The reason for the elections is that the terms of office for these positions will expire at the end of this year.
3. The electorate for the elections is the total membership.
4. The date requested for nominations to open is at a date to be determined by the Returning Officer but no later than 15 September 2021 (rule 52BH (1)).
5. The date requested for nominations to close is at a date to be determined by the Returning Officer but no later than 12 noon on 10 October 2021 (rule 52BH (2)).
6. The date the roll of voters will close is at a date to be determined by the Returning Officer which will be 7 days before the day nominations are declared open (rule 52BH (1)).

7. The voting system that we request be employed is the direct voting system.
