Arrangement for conduct of election.

- [1] On 1 March 2021 the National Electrical and Communications Association (the **organisation**) lodged prescribed information with the Registered Organisations Commission (the **Commission**) seeking an election for a number of offices of the organisation and its branches for a new term of office.
- [2] The prescribed information indicated that the number of Branch Councillors to be elected to the Queensland Branch was ten (10).
- [3] On 8 April 2021, I issued decision [2021] ROCD 51 in this matter, as Delegate of the Registered Organisations Commissioner, to arrange for the Australian Electoral Commission (**AEC**) to conduct an election for the offices specified in the prescribed information.
- [4] The rules of the organisation permit a Branch to determine the number of Branch Councillors to be elected.
- [5] On 29 April 2021, the organisation wrote to the Commission to inform it that the prescribed information lodged on 1 March 2021 (and on which my 8 April 2021 decision was based), had omitted particular information. That information was that on 16 September 2020 the Queensland Branch Council had passed a resolution that its Branch Council would be comprised of eight (8) councillors, not ten (10).
- [6] On 29 April 2021 the organisation also lodged amended prescribed information to reflect that an election was sought for eight (8), not ten (10), Branch Councillors of the Queensland Branch and requested that the Commission issue an amending decision
- [7] Having considered the information provided by the Branch, I am satisfied that the number of Branch Councillors to be elected for the Queensland Branch is eight (8) Councillors. I note that the election for these offices has not yet been commenced by the AEC.
- [8] The decision issued in this matter on 8 April 2021, [2021] ROCD 51, is amended as follows:

By deleting 'Branch Councillors (10)' from the list of offices of the Queensland Branch at paragraph [3] and inserting in lieu:

'Branch Councillors (8)'
