Arrangement for conduct of election.

- [1] On 18 January 2021, the Australian Road Transport Industrial Organization (the organisation) lodged prescribed information with the Registered Organisations Commission seeking an election for certain offices as the organisation had reconstituted its Western Australian Branch (the Branch).
- [2] On 24 February 2021, as Delegate of the Registered Organisations Commissioner, I issued a decision in this matter, [2021] ROCD 22. However, it has since been brought to my attention that one of the offices for which an election was sought by the organisation was inadvertently omitted from my decision, namely the office of Branch Secretary/Treasurer.
- [3] As I am satisfied that an election is also required for that office, as well as the offices listed in my original 24 February 2021 decision, [2021] ROCD 22 is amended as follows:

By adding the office of 'Branch Secretary/Treasurer (1)' to the list of offices at paragraph [1]

Arrangement for conduct of election.

[1] On 18 January 2021 the Australian Road Transport Industrial Organization<sup>1</sup> (the ARTIO) lodged with the Registered Organisations Commission prescribed information for an election to fill the following offices:

## Western Australian Branch

[2] These are new offices, created as a consequence of a resolution by the ARTIO National Council on 23 September 2020 agreeing to establish a new Western Australian Branch of the organisation. The prescribed information lodged by ARTIO indicated that the Branch was created on 17 November 2020. Rule 7 of the ARTIO rules empowers the ARTIO Council to constitute Branches from time to time. (I note that a Western Australian Branch had previously existed but was disbanded by resolution of the ARTIO Council on 16 July 2018).

[3] Branch Rule 10 of the ARTIO rules vests the management of a Branch in a Branch Committee, subject to the general control of members of that Branch. Branch Rule 11 provides that each Branch shall determine the number of members of the Branch Committee subject to certain parameters set out in that rule, such as minimum and maximum numbers of Branch

Committee members. The office bearers drawn from among the Branch Committee are set out in Branch Rule 14.

- [4] Rule 7(5) of the ARTIO rules provides that where the organisation creates a new Branch, the term of the officers elected at the Branch's first election will expire at the same time as the terms of office of other (pre-existing) ARTIO branches. The prescribed information lodged by the ARTIO indicates that the expiration will be in or around December 2022.
- [5] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

## Prescribed Information for elections by the Australian Road Transport Industrial Organization (ARTIO)

I, Peter Anderson, National Secretary/Treasurer of ARTIO state that the information is lodged under section 189 of the Fair Work (Registered Organisations) Act 2009 and that I am the person authorised to make the statement.

ARTIO hereby lodges prescribed information in respect of elections to be conducted by the Australian Electoral Commission.

### Offices and voting system

### Western Australian Branch

- ➤ Branch Committee Members (6) direct voting system election
  - Branch President by and from Branch Committee
  - Branch Secretary/Treasurer by and from Branch Committee
  - Branch Vice Presidents (2) by and from Branch Committee
  - Branch Committee Officers (2) by and from Branch Committee

- o Branch Alternate Representative to Council by and from Branch Committee

### Reason for election - regular branch election

Pursuant to rule 7(5), a regular branch election for the aforementioned offices is required following the creation of the new Western Australian Branch on 17 November 2020. The term of office of persons elected pursuant to the subject election shall expire to coincide with the expiration of the terms of office of the pre-existing branches of the Organization – which will be in or around December 2022.

### Electorate

The voting electorates of the branch committee members (6) is by direct voting system of all financial members of the Western Australian Branch.

The voting electorate for the Branch (and Alternate) Representatives to Council is the college comprising the respective Branch Committee. Note that Branch (and Alternate) Representative to Council may also hold office of a branch.

The voting electorate for all other branch offices is the college comprising the respective Branch Committee.

#### Nominations open and close

Branch Committee Members (6) - DVS

To be determined by the AEC Returning Officer having regard to the period available for lodging nominations under Branch rule 12(5).

Branch Office Bearers and Representatives to Council – CES

To be determined by the AEC Returning Officer having regard to the period available for lodging nominations under Branch rule 14(2) – which is also incorporated by reference at federal rule 25(4).

### Roll of voters to be closed

Rule 24A(7) has general application. It provides:

"The roll of voters for any ballot required under these rules shall close 7 days before the day on which nominations for the election open."

## **Voting system**

The voting system as between a direct voting system and a collegiate electoral system (referenced by the words "by and from") is identified above in respect of each of the abovenamed offices.

## **Pending Rule Alterations**

The organisation has no outstanding rule alterations pending with the Fair Work Commission at the present time.

It should also be noted that this prescribed information is the first lodgement since extensive rule alterations were certified on 5 June 2020 (ref: [2020] FWCD 1869).
