

Arrangement for conduct of election.

- [1] On 30 March 2020 the National Tertiary Education Industry Union (the organisation) lodged with the Registered Organisations Commission (the Commission) prescribed information under section 189 of Fair Work (Registered Organisations) Act 2009 (the Act) seeking an election to fill several National, Divisional and Branch offices. In addition, the prescribed information also requested an election under section 187 of the Act to fill several Sub-Branch positions.
- [2] Included in the prescribed information was a request to fill offices in the Bond University Branch and the Australian Film Television and Radio School Branch.
- [3] On 26 May 2020, a Delegate of the Commissioner issued an election decision in this matter, [2020] ROCD 77, arranging for an election of the above-mentioned offices and positions. Due to the COVID-19 pandemic and associated restrictions, conduct of the election was delayed with the result that nominations are now scheduled to open on 24 March 2021.
- [4] On 24 February 2021, the organisation lodged with the Commission a declaration of notification of changes to records, in accordance with section 230 of the Act, stating that the Bond University Branch and the Australian Film and Radio School Branch had been abolished by resolution of the organisation's National Council, in accordance with the provisions for the dissolution of branches as set out in its rules. All offices of those Branches were therefore abolished.
- [5] In light of the abolition of the two branches, I am satisfied that an election for offices of the Bond University and the Australian Film and Radio School Branches are no longer required and will inform the Australian Electoral Commission accordingly.

- I, **Matthew McGowan**, General Secretary of the National Tertiary Education Industry Union, hereby request, pursuant to Section 189 of the Fair Work (Registered Organisations) Act 2009, that the General Manager arrange for the conduct of this organisation's elections in 2020:
  - 1. Elections are required for those offices specified in the attached table, Attachment B.
  - 2.
- (a) **The name of each office** (Regulation 138(1)(a)) is specified in the first and second columns of Attachment B.
- (b) The reason for the election (138(1)(b)) is as specified in the fifth column of Attachment B, according to the Key to Election Request which is at the Annexure to Attachment B.
- (c) Where more than one of the offices in respect of which an election is required have the same name (138(1)(c)) the number of such offices is as specified in the third column of Attachment B, headed "No. Required".
- (d) The electorate from which each office is to be elected (138(1)(d)) is as indicated in the fourth column of Attachment B, headed "Elected By", read in conjunction with the Annexure to Attachment B.
- (e) **The voting system to be employed** (138(1)(g)) in the conduct of the election is as indicated in the sixth column of Attachment B read in conjunction with the Annexure to Attachment B.
- (f) The period during which nominations may be called (138(1)(e)) is 1 March 2020, to such date as would see the elections declared before the terms of office commence, except that no time is prescribed by the rules in relation to new positions. To be determined by the returning officer.
- 3. The terms of office for each office in the attached table is two years, except that it is four years for the positions of Division Secretary in Australian Capital Territory, New South Wales, South Australia and Western Australia, which are designated as full-time offices (Rule 69.8). No election is required for Division Secretary in the Queensland and Victorian Divisions, which have four-year terms from 2018.

- 4. I have included in Attachment B in the left hand column in respect of each Branch where it is relevant in determining the number of National Councillors a Branch is to elect, the number of members of the Branch (Rule 18.1). This number is in brackets e.g. ("897"). The listed number is based, as required by the rules, on the membership numbers according to the best records held by the General Secretary as at 28 February 2020 (Rule 18.1).
- 5. Specifically, you will note that the Victorian TAFE Branch has a National Councillor to be elected and the ACE and Companies Branch has a National Councillor to be elected, pursuant to the terms of Sub-Rule 18.3. In both cases, these are Branches established in respect of a sector.
- 6. The date provided for in the rules as the day on which the roll of voters is to be closed (138(1)(f)) is the seventh day before the date determined for the opening of nominations (72.1).
- 7. In accordance with Rule 18.3 I, an election is only requested for the position of Aboriginal & Torres Strait Islander Branch Committee Member at those Branches where, according to the Union's records today, the Union has Indigenous members. I have caused the records of the Union to be checked in respect of each Branch and the requests corresponds to the result of that check.
- 8. Other than the ANU Branch, I can confirm that each of the entities entitled to elect an Additional Divisional Councillor in the ACT Division each has less than 400 members.
- 9. I can confirm that the University of Tasmania Branch continues to be the only Branch in Tasmania.
- 10. As per rule 27.14 there are no Branches of the Union established in the Northern Territory and the Division Officers and Division Council in the Northern Territory Division shall be as set out in this sub-rule
- 11. Attachment C to this statement sets out those positions which are required to be elected under the Rules of the NTEU but which are not considered to be offices as defined in Section 9 of the Fair Work (RO) Act 2009. NTEU requests that the elections for these positions be conducted by the AEC in accordance with s.187 of the Fair Work (RO) Act 2009.

That Decision included approval of an alteration to rule 35, to read as follows:

35.1 The Branch Officers shall be the President, the Branch Secretary and the Branch Vice-President, provided that where both the number of academic staff members and the number of general staff members exceeds twenty, there shall be two Branch VicePresidents with the status of Branch Officers; and Vice-President (Academic Staff) who shall be elected by and from among the academic members of the Branch and a Vice-President (General Staff), who shall be elected by and from among the general staff members of the Branch in accordance with Rule 73.

Whereas during 2019 an alteration was adopted to these rules which had the effect of abolishing the position of Branch Treasurer, but notwithstanding that alteration to the rules, any Branch Treasurer who held office at the time of the approval of that alteration is entitled to continue to hold that office subject to these rules; and while they continue in that office, continues to exercise the powers, and to have the duties which attached to that office as at the time of their election. In the case of a Branch Committee which included the office of Branch Treasurer elected in 2018, then absent any decision to the contrary of that Branch under these rules, the size of the Branch Committee shall not be reduced for the next ordinary elections in that the number of Ordinary Branch Committee members shall be increased by one.

This alteration has had the effect of abolishing the office of Treasurer in these Branches – the only branches which elected to have such an office – and to increase the number of Ordinary Branch Committee members by one. This Request reflects that alteration.

It was our hope to advertise nominations from late May 2020, but due to the AEC not conducting elections at this time we would ask that we can conduct them at the earliest time possible. It would therefore be appreciated, if this request could be approved as soon as possible.
