RE: E2021/121 NTEU – Withdrawal of Application to conduct own elections under Section 183

I am writing on behalf of the National Tertiary Education Industry Union about the Application(s) made by the Union under Section 183 of the *Fair Work (Registered Organisations) Act 2009* which was lodged with the Commission on 2 June 2021.

The circumstances giving rise to the Application were set out in the Application itself and included that we were advised to consider this course of action by officers of the Australian Electoral Commission (AEC). One of the central purposes of the Application was to allow attendance ballots to take place in 2021 for collegiate elections in coming weeks.

However, the continuing and unpredictable lockdowns in most States and Territories, together with the AEC's willingness to run a postal ballot for these elections most expeditiously, have caused the NTEU National Executive to resolve unanimously today to direct that the Union write to the Commission advising that it withdraws the Application. Please take this letter as that withdrawal.

While we understand that an exemption granted under Section 183 does not necessarily have to be used, the Application itself was time-bound and therefore there is no real prospect that any exemption would be used. The Union therefore believes it would be a waste of the Commission's resources and ours to proceed with the hearing scheduled for this matter and its determination.

These are applications made under Section 183(1) of the Act, and in accordance with the Regulations, for the NTEU to conduct its own elections for certain specified offices, as listed in **Attachment A** to this Application, being elections for all positions elected by collegiate election at meetings, until 1 April 2022.

Declarations by a member of each of the relevant committees of management of relevant facts are **Attachment B** to these Applications.

Grounds of Applications

The Grounds on which these applications are made in each case are in substance the same, and are as follows:

- The Australian Electoral Commission ("AEC") advised the NTEU in 2020 of a significant delay in the conduct of the NTEU's biennial elections which would in the normal course of events, have been conducted in 2020, such that the elections for positions by direct method due to be conducted in 2020 are still being conducted, and election by the collegiate method, which in the normal course of events need to be conducted after the declaration of the direct elections.
- 2. Moreover, and of greater significance, the AEC has advised the NTEU that until further notice it will not attend meetings of NTEU bodies to conduct in-person elections.
- 3. Under the NTEU Rules, certain collegiate elections are specified as occurring at meetings. So much is apparent, for example, from the following provisions of the NTEU Rules:

- 69.3 (a) The positions of Ordinary Executive Members on the National
 Executive shall be elected by and from the members of the
 National Council at the Annual General Meeting of the National
 Council, in accordance with the provisions of Rule 70.A.
- 69.4 (a) The positions of Division President, and ordinary Division
 Executive Members in each Division shall be elected by and
 from the members of the Division Council at a meeting of the
 Division Council
- 69.6 (a) The Division Vice-Presidents shall be elected by the Division
 Council from among the Members of the Section to which each
 of those offices relates. The Division Executive members shall
 be elected by and from the members of the Division Council.
 These elections shall be conducted during the Division Council
 meeting convened under sub-rule 69.4.
- 18.3 D After the membership of the Aboriginal and Torres Strait
 Islander Policy Committee is known, the General Secretary or
 the outgoing Chairperson of the Committee shall convene a
 meeting of the Committee, to be held during the 4 weeks prior
 to the Annual General Meeting of the National Council, to elect
 the Chairperson of the Aboriginal and Torres Strait Islander
 Policy Committee and the Deputy Chairperson of the Aboriginal
 and Torres Strait Islander Policy Committee.
- 36.3 [The Victorian TAFE Branch]

 Whenever the arrangements under this sub-rule are in effect in respect of a Branch, the Branch Officers and National Councillors from such a Branch shall have a term of office from the end of the meeting at which they are elected, until the election of their successors in the second year following
- 4. Therefore, it follows that the collegiate elections which, under the Rules of the NTEU, should have been conducted in 2020, cannot even be conducted in 2021 unless either:
 - a. They are conducted by post by the AEC, which is not provided for in the Rules; or
 - b. The NTEU is permitted to conduct these elections itself.

The intention underlying the rules is that these elections be conducted in a collegiate and deliberative environment, with the electors having the opportunity to discuss among themselves who would be the better candidates. This would be lost if these elections were conducted by post. Of even greater importance, the delay in elections which would in the normal course of events be conducted before the National Council and would provide some of the voting members of the annual meeting of

- the National Council (held in early October), would be seriously delayed or would be such that this year's National Council would include members elected in 2018.
- 5. NTEU now turns to the requirements of Section 186 of the Act. Elections conducted at meetings with scrutineers are highly transparent and relatively simple to conduct. The voters in such elections are far more sophisticated and conscious of the requirements of the rules than the average voter in a direct postal election. It is almost inconceivable that any irregularity could occur. The NTEU has staff and officers highly experienced in the conduct of elections and will appoint appropriate independent returning officers retired members and former members.
- 6. The NTEU has no history of voter intimidation, nor even of allegations of voter intimidation, and in its history of thousands of elections conducted since amalgamation in 1993 and in respect of its federally registered predecessors prior to that, the NTEU has never been the subject of any adverse judicial or administrative finding of any election irregularity. There is no risk, or a vanishingly small risk of any intimidation of voters.
- 7. Collegiate elections are held at offices of the Union either the National Office, the relevant Division office or, in the case of the National Council and the Aboriginal & Torres Strait Islander Policy Committee, at the time and place of the meeting. All these elections are held at meetings of the relevant bodies. Therefore, the relevant members will have an adequate opportunity to vote.
- 8. The technical requirements for these applications have been met. A Notice to members in the required form has been placed on the website of the Union and of each relevant Branch and Division.
