Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia (E2021/174)

Arrangement for conduct of election.

[1] On 16 September 2021 the New South Wales Telecommunications and Services Branch (the Branch) of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia (the organisation) lodged prescribed information with the Registered Organisations Commission (the Commission) for an election to fill the following office, due to insufficient nominations received in a previous election (E2018/281):

Branch Committee of Management Member (Operator Industry Section) (1)

- [2] I also note that the prescribed information lodged in this matter relates to an office for which insufficient nominations were received in the scheduled election E2018/281 which was declared on 3 May 2019, i.e. more than two years ago.
- [3] Relevantly, rule 69(a) of the organisation's Communications Division rules provides that:

In the event that any Branch Officer or Branch Committee of Management position becomes vacant for any reason and the unexpired part of the term is more than twelve (12) months or three quarters of the term of office before the date of the closing of the ballot for the next election whichever is the greater, the vacancy shall be declared vacant by the Branch Committee of Management at its next scheduled meeting following the occurrence of the vacancy. The election shall be conducted in the same manner and subject to the provisions of Rules 66 and 67.1

[4] The Branch advised the Commission that the membership from which this particular office is drawn is relatively small and that consequently it was sometimes difficult to achieve nominations, inferring that this was the reason for not seeking an election earlier. The Branch expressed confidence that the office may be filled through the election that it now seeks.

- [5] I note that even if were not a specific rule in either the rules of the organisation or of the relevant Division stipulating a specific process or timeframe for the conduct of an election arising out of earlier insufficient nominations (in this case for a Branch Committee of Management Member from a specific section of the Branch), it is apparent from the objects of the RO Act, particularly the principles of democratic control, that organisations and their branches need to make reasonable attempts to fill all offices, including those where vacancies arise through insufficient nominations being received.
- [6] In this regard, I draw attention to the decision in *Geneff v Peterson and Ors* [1986] FCA 432, in particular the comments of Gray J at 129 that:²

If insufficient nominations are received, then further elections must be held and further nominations called for. This process must continue, for as long as vacancies exist on the Executive Committee. In the meantime, however, a branch is not to be paralysed by the inability of its decision-making body to function.

- [7] I therefore take this opportunity to remind the Branch that where insufficient nominations are received at future scheduled elections or indeed if insufficient nominations are received in the election to be arranged for this particular office it should lodge prescribed information in a more timely manner in an attempt to fill such office(s).
- [8] I understand, from communications between the Commission and the organisation, that the national office of the organisation has correspondence with branches about the need to take steps to fill vacant offices. Such action by the national office is commendable and it is hoped that it will reduce instances of long delays in seeking to fill vacant offices.
- [9] I am satisfied that an election for the abovenamed office is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
