Arrangement for conduct of election.

[1] On 5 October 2021 the South Australian Divisional Branch of the Electrical, Energy and Services Division of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia (the organisation) lodged with the Registered Organisations Commission prescribed information for an election to fill the following office, due to insufficient nominations received in a previous election (E2019/63):

Divisional State Councillor - Gas Supply (1)

- [2] I note that the Branch's letter dated 5 October 2021, which accompanied the prescribed information lodged in this matter, acknowledges that it relates to an office for which insufficient nominations were received in an election declared on 24 July 2019, i.e. more than two years ago.
- [3] The letter also notes that the lodgement of prescribed information follows the National Secretary of the organisation corresponding with branches on 9 September 2021, drawing their attention to my decision in matter E2021/78. In that decision it was indicated that attempts must be made to fill vacant offices, including those resulting from insufficient nominations being received, and the need for this to occur in a timely manner. In relation to the current matter (E2021/187), I commend the Branch's candour in acknowledging its omission of not acting on this vacancy sooner and note its apology in this regard.
- [4] I also take the opportunity to note that if insufficient nominations are received in the election to be arranged for this particular office (or in future elections), the Commission's clear expectation is that prescribed information would then be lodged by the relevant organisation or branch in a timely manner in an attempt to fill such office(s). I also take this opportunity to commend the organisation's national office on its efforts to address this issue with its branches.
- I am satisfied that an election for the abovenamed office is required to be held under the rules of the organisation and, under subsection 189(3) of the Fair Work (Registered
