Arrangement for conduct of election.

[1] On 24 September 2021 the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia – Electrical, Energy and Services Division – Western Australian Divisional Branch lodged with the Registered Organisations Commission prescribed information for an election to fill the following office, due to insufficient nominations received in a previous election (**E2019/65**):

Divisional State Councillor – Foundry Industry Section (1)

- [2] The covering letter from the Branch which accompanied the prescribed information lodged in this matter acknowledged that it relates to an office for which insufficient nominations were received in the scheduled election E2019/65 which was declared on 13 August 2019, i.e. some two years ago. The Branch acknowledged the delay in lodgement and noted a decision issued by the Commission earlier this year in relation to another branch of the organisation (E2021/78), which drew attention to the need for organisations and branches to take steps to fill vacant offices, including those for which insufficient nominations are received.<sup>1</sup>
- [3] It is apparent, from the Branch's letter accompanying the prescribed information and from communications between the Commission and the organisation, that the national office of the organisation has corresponded with its branches about the need to take steps to fill vacant offices, and drawn their attention to the Commission's decision in E2021/78. Such action by the national office is commendable and it is hoped that it will reduce instances of long delays in seeking to fill vacant offices.
- [4] In the event that insufficient nominations are received in the election to be arranged for this particular office (or arising from future scheduled elections), the Commission's expectation is that the Branch would lodge prescribed information sooner in an attempt to fill such office(s).

<sup>1</sup> The decision in that matter referred to the observations of Gray J in *Geneff v Peterson and Ors* [1986] FCA 432, at 129, namely: "If insufficient nominations are received, then further elections must be held and further nominations called for. This process must continue, for as long as vacancies exist on the Executive Committee. In the meantime, however, a branch is not to be paralysed by the inability of its decision-making body to function."

[5] I am satisfied that an election for the abovenamed office is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

#### CEPU EE&S Division - WA Branch - Insufficient nominations elections

With reference to the above, I attach:

- Prescribed information for an election as required by 189(1) of the Fair Work (Registered Organisations) Act 2009 (the Act) and Regulation 138 of the Fair Work (Registered Organisations) Regulations 2009;
- AEC Declaration of Result E2019/63

I refer to the correspondence sent to the ROC by the National Secretary, Allen Hicks, on 9 September regarding an insufficent nominations election for this Branch. In his correspondence Mr Hicks noted the decision of the ROC in E2021/78 where in respect of an insufficient nominatons election request by the CEPU Tasmanian Branch, the ROC drew attention to the decision of *Geneff v Peterson and ors* [1986] FCA 432, and the comments of Justice Gray that if insufficent nominations are received in an election, then further elections must be held.

This has prompted the Branch to advise the ROC of an office which was likewise not filled at the previous quadrennial election (E2019/65) and for which prescribed information for an insufficient nomination election should also be lodged in an attempt to fill the office.

The office which was not filled at the previous election is as follows:

• State Councillor – Foundry Section

Accordingly, the Branch requests that the Registered Organisations Commission arrange an election to be conducted by the Australian Electoral Commission for this position.
