Other Matters

Returning Officer actions required (Section 193): Yes Details:

- The Rules of the Association were set aside, and nominations were to be lodged via email/ AEC portal to ensure that no irregularities would occur as a result of the restrictions imposed by the Coronavirus pandemic and current Australia Post delivery times.
- As there is no rule pertaining to the withdrawal of nominations, the Returning Officer fixed a closing time for withdrawal of nominations to align with the close of the nomination period.
- The Rules of the Association state that the ballot is to open within 14 days of the close of nominations. The Returning Officer deemed that this time frame was not sufficient to ensure that no irregularities would occur when checking the eligibility of nominations received and to ensure the documents for the ballot were correct. To address the issue, the Returning Officer opened the ballot within 6 weeks of the close of the nomination.
- The Rules of the Association state that the ballot period needs to be closed on the 12th day of April. Due to the impact of Covid-19 the Returning Officer closed the ballot period by 13/04/2022 for the Stage 1 election.
