Formality rules in SA LGA Act conflict with the AEU SA Branch formality rules.

### **SA Branch AEU**

Rule 52(9) The method of voting and of counting votes in an election conducted by secret postal ballot shall be that set out in sections 45 and 48 of the South Australian Local Government (Elections) Act 1999.

Rule 52(11) Any vote in respect of the election of a person to an office shall be informal if:-

(b) the content of the ballot paper does not comply with the instructions printed on it;

### **SA LGA Act**

#### **45—Method of voting at elections**

- (1) To make a formal vote at an election a person must make a vote on the ballot paper—
  - (a) if only one candidate is required to be elected—by placing the number 1 in the square opposite the name of the candidate of the voter's first preference and, if the voter so desires, by placing the number 2 and consecutive numbers in the squares opposite the names of other candidates in the order of the voter's preference for them;
  - (b) if more than one candidate is required to be elected—by placing consecutive numbers beginning with the number 1 in the squares opposite the names of candidates in the order of the voter's preference for them until the voter has indicated a vote for a number of candidates equal to the number of candidates required to be elected and then, if the voter so desires, by continuing to place consecutive numbers for one or more additional candidates in the order of the voter's preference.
- (2) A tick or cross appearing on a ballot paper is equivalent to the number 1.
- (3) If—
  - (a) a series of numbers (starting from the number 1) appearing on a ballot paper is non-consecutive by reason only of the omission of one or more numbers from the series or the repetition of a number (not being the number 1); and

(b) if more than one candidate is required to be elected—the numbers are at least consecutive up to the number of candidates required to be elected, The ballot paper is not informal and the votes are valid up to the point at which the omission or repetition occurs.

(4) A ballot paper is not informal by reason of non-compliance with this section if the voter's intention is clearly indicated on the ballot paper.

## Other Matters

---

Returning Officer actions required (Section 193): Yes

Details:

### **Timetable**

Application of s.193 of the Act is required to adjust the election timetable s as a consequence of restrictions caused by the coronavirus pandemic.

Rules regarding the timetable of the election were set aside as the AEC held concerns that the coronavirus pandemic may impact on the ability for stakeholders to fully participate in the election. A timetable for the conduct of the ballot which varied from the rules was set when the AEC was satisfied that stakeholders would be able to fully participate.

### **Withdrawal of nominations.**

Application of s.193 of the Act is required to allow for the withdrawal of Nominations at the same time as the close of nominations.

### **Preliminary scrutiny**

52 (13) Immediately after the time determined for the close of the ballot, the Branch Returning Officer shall, in the presence of such scrutineers as are present, take steps to ensure that no further ballot papers are deposited in the ballot box and then proceed to:-

- (a) open the ballot box and remove unopened ballot paper envelopes;
- (b) determine, prima facie, the bona fides of the ballot papers by reference to the membership register as at the closing date for nominations for that election;

### **Model Rule**

#### **17.2 Preliminary Scrutiny of envelopes**

The returning officer shall conduct a preliminary scrutiny of returned declaration envelopes to ensure that only one returned envelope from each eligible voter is admitted to the count. The returning officer may commence the preliminary scrutiny prior to the close of the ballot.

**Recommendation:**

The AEU may wish to consider allowing the returning office to commence preliminary scrutiny of returned declaration envelopes prior to the close of the ballot. Thus allowing the scrutiny to commence soon after the close of the ballot.
