*Fair Work (Registered Organisations) Act 2009*  
s.189—Arrangement for conduct of an election

*Arrangement for conduct of election.*

[1] On 21 December 2021 the Northern Territory Branch (**the Branch**) of the Australian Hotels Association lodged with the Registered Organisations Commission prescribed information for an election to fill the following office for a new term of office:

Representative to National Accommodation Hotels Division (1)

[2] On 18 January 2022, I issued a decision in this matter indicating that I was satisfied that an election for the abovenamed office was required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, made arrangements for an election to be conducted by the Australian Electoral Commission (AEC).

[3] The AEC has not yet conducted this election. In the meantime, another scheduled election for offices in the Branch, including the abovenamed office, has now become due (election matter **E2022/225**) – for which the Branch recently lodged prescribed information and for which a decision, [2022] ROCD 183, was issued yesterday (19 December 2022).

[4] On the basis of the decision issued in E2022/225, the office of Representative to National Accommodation Hotels Division will be included in that election. A separate election for that office under E2021/214 would, in effect, be a duplication and my decision in E2021/214 is therefore amended such that the AEC is now not required to conduct election E2021/214.

*Arrangement for conduct of election.*

[1] On 21 December 2021 the Northern Territory Branch (**the Branch**) of the Australian Hotels Association (**AHA**) lodged with the Registered Organisations Commission (**the Commission**) prescribed information for an election to fill the following office:

Representative to National Accommodation Hotels Division (1)

[2] On 21 December 2021, the Branch advised the Commission that in relation to the other AHA national body on which the Branch is represented, the AHA National Board, the AHA rules provide that where a Branch only has one Delegate to National Board – as is the case for this Branch – that office is filled by the Branch President *ex officio*, in accordance with rule 11.5.

[3] In relation to the office of Representative to National Accommodation Hotels Division, I am satisfied that an election for that office is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
