DECISION

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Australian Hotels Association

(E2021/211)

Arrangement for conduct of election.

[1] On 22 December 2021, the Queensland Branch (**the Branch**) of the Australian Hotels Association (**AHA**) lodged prescribed information with the Registered Organisations Commission (**ROC**), and on and 17 January 2022 lodged amended prescribed information, for an election to fill the following offices for a new term of office:

Delegates to National Board (in addition to the Branch President as *ex officio* Delegate) (5)

Representatives to National Accommodation Hotels Division:

Northern Zone	(1)
Southern Zone	(1)

[2] The AHA rules currently require an election for the abovementioned offices to be conducted annually. The Branch's lodgement of prescribed information was required because section 189 of the *Fair Work (Registered Organisations) Act 2009* (**RO Act**) requires organisations and branches to lodge prescribed information if an election is required under their rules. The Branch has therefore met the obligation under section 189 of the RO Act to lodge prescribed information for elections in accordance with its rules.

[3] However, the conduct of the previous scheduled election for the abovementioned offices (E2020/216) – which sought to have an election conducted in 2021 – was delayed due to the Covid-19 pandemic. The ROC understands that election E2020/216 is currently being conducted by the Australian Electoral Commission (AEC). The ROC acknowledges that the election dates for E2020/216, as required under the organisation rules, have been impeded by the Covid-19 pandemic delays and accepts that this is outside the control of the organisation and the AEC.

[4] While subsection 193(1)(a) of the RO Act requires that an election official (i.e. an AEC Returning Officer) must conduct an industrial election in accordance with the rules of the organisation or branch, this is subject to the provisions of subsection 193(b). That subsection permits an election official may take such steps as to avoid irregularities in the conduct of the election, remedy any procedural defects that appear to exist in the rules, or ensure the security

of ballot papers and envelopes used in the election.¹ Consequently, it is open to the AEC to take steps such as conducting an election under a revised timetable if the circumstances require it.

[5] It should be noted that rule 44A of the AHA rules, which was implemented due to the Covid-19 related delay to the earlier scheduled election E2019/217, provides that while the term for the abovementioned offices commencing in 2019 was extended as a one-off measure, the term of office will revert to one year for the officers that are declared elected in E2020/216 and for subsequent elections.

[6] Given that running election E2021/211, in circumstances where another election for the identical offices is already underway, would (in practical terms) duplicate the election currently being held (E2020/216), I have determined that the AEC is not required to also conduct election E2021/211 - provided that election E2020/216 is completed.
