Returning Officer actions required (Section 193): Yes Details:

- As there is no rule pertaining to the withdrawal of nominations, the Returning Officer applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisations) Act 2009 to fix a closing time for the withdrawal of nominations and the withdrawal period was aligned with the nomination closing date.
- Branch rule 10.4 provides the election of members of Branch Executive shall be in accordance with Federal Rule 17, with any necessary changes. Federal rules 17(p) and 17(r) state that the ballot is to be closed on the 22nd day after the opening of the ballot. Due to delivery times taken by Australia Post, the ballot period provided for in the rules was considered not sufficient. The Returning Officer applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to extend the period and allowed 28 days instead of 22 days.

Arrangement for conduct of election.

[1] On 10 March 2022 the NSW/ACT Branch of the Independent Education Union (the **Branch**) of Australia lodged with the Registered Organisations Commission (the **Commission**) prescribed information for an election to fill the following offices for a new term of office:

President	(1)
Vice President	(5)
Financial Officer	(2)
Branch Secretary	(1)
Branch Deputy Secretary	(1)
Branch Assistant Secretary	(2)
General Executive Members	(10)
Branch Delegates to Federal Council	(16)
Deputy Branch President	(1)
Alternative Delegate to Federal Executive	(1)

- [2] The rules of the organisation provide that where a collegiate election for office-bearers is required, this is to be held as soon as possible after the direct election of the Branch Executive has been declared.
- [3] The rules also provide that the Branch Secretary must supply, to the Returning Officer, a Certificate that shows the percentage of financial women members as at 31 December of the preceding year. Where that percentage is greater than 50% then the number of Delegates to Federal Council cannot be comprised of fewer than 50% women.
- [4] In reviewing this matter, Commission staff also identified an apparent contradiction in relation to the term of office for Branch Delegates to Federal Council. The Branch rules appear to indicate a term of 2 years, whereas the Federal rules appear to indicate a term of 3 years. I

therefore encourage the organisation and the Branch to review its rules with a view to addressing this issue.

[5] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
