**You must take steps after your recent election E2021/193**

Dear Matthew McGowan,

An election has recently been completed by the Australian Electoral Commission (**AEC**) for the National Tertiary Education Industry Union.

This letter explains the next steps you must take and what information you need to lodge with the Registered Organisations Commission (**ROC**).

**What you must do right now**

- Let your members know about the election report issued by the AEC
- Arrange financial training for officers newly elected to an office with financial management duties. (This includes all members of the committee of management).
- Complete the notification of change and email it to [regorgs@roc.gov.au](mailto:regorgs@roc.gov.au)

This letter explains these steps and the tools available to help you.

**STEP 1: Notify members**

You must put a notice on your website once you receive your post-election report. It must tell your members they can request a copy of the post-election report from you or the AEC (r. 141). The notice must be on your website for at least 3 months.



**Can I put more information on our website?**

Yes! Being transparent is part of good governance. You can publish the whole report or the declaration of results, as well as your notice and leave them up longer than 3 months. You can always do more than the regulatory minimum.

The ROC will also publish your declaration of results on our [website](#).

**STEP 2: Financial training**

You may have to arrange financial training for people elected to new roles.

All officers with financial management duties must complete financial training (s 293K). For information on when officers must redo training and hints on when to book training for officers taking up multiple offices [please see our fact sheet](#).

There are face to face and online [financial training packages on the ROC website](#).

You must act on this now, as affected officers **MUST** complete approved financial training OR been granted an [exemption by the ROC within 6 months](#) of beginning to hold office.

## STEP 3: Notifications of change

A notification of change must be lodged with the ROC within **35 days** of the change occurring.



We have a [template](#) to help you with this, which you can send to [regorgs@roc.gov.au](mailto:regorgs@roc.gov.au). An officer must sign the completed notification template.

You must lodge a notification of change if:

- any of your officers have not been re-elected;
- officers have changed offices; or
- you have new officers.

Only notify us of changes that have **already occurred**. If people take up office in the future, you must wait until the change happens before lodging the notification within 35 days of the change.

**Note:** One election may result in many notifications of change.



### Penalties apply

Failing to lodge your notifications of change on time can expose your organisation and its officers to significant penalties.

#### ROC v CEPU

The organisation failed to make a series of notifications of change on time.

The Full Court said 'The record-keeping obligations imposed under the Registered Organisations Act are treated by the legislature as important and serious, and contravention of those obligations are correspondingly serious.'

The organisation was ordered to pay a penalty. More information is available in our [case summary](#).

### **Why do I need to tell you the results of the election when you've already received them?**

The RO Act requires that **you** tell us this information about your officers – it is a legal obligation. The notification of change also contains information that is not in the declaration of results.

Dear Matthew McGowan,

An election has recently been completed by the Australian Electoral Commission (**AEC**) for the National Tertiary Education Industry Union.

This letter explains the next steps you must take and what information you need to lodge with the Registered Organisations Commission (**ROC**).

### **What you must do right now**

- Let your members know about the election report issued by the AEC
- Arrange financial training for officers newly elected to an office with financial management duties. (This includes all members of the committee of management).
- Complete the notification of change and email it to [regorgs@roc.gov.au](mailto:regorgs@roc.gov.au)

This letter explains these steps and the tools available to help you.

### **STEP 1: Notify members**

You must put a notice on your website once you receive your post-election report. It must tell your members they can request a copy of the post-election report from you or the AEC (r. 141). The notice must be on your website for at least 3 months.



**Can I put more information on our website?**

Yes! Being transparent is part of good governance. You can publish the whole report or the declaration of results, as well as your notice and leave them up longer than 3 months. You can always do more than the regulatory minimum.

The ROC will also publish your declaration of results on our [website](https://www.roc.gov.au).

### **STEP 2: Financial training**

You may have to arrange financial training for people elected to new roles.

All officers with financial management duties must complete financial training (s 293K). For information on when officers must redo training and hints on when to book training for officers taking up multiple offices [please see our fact sheet](#).

There are face to face and online [financial training packages on the ROC website](#).

You must act on this now, as affected officers **MUST** complete approved financial training OR been granted an [exemption by the ROC within 6 months](#) of beginning to hold office.



### Good governance tip:

Organisations should instruct officer holders about their other obligations. This is especially important for committee of management members.

Officers have responsibilities under the rules, the RO Act, and disclosure requirements around conflicts of interest, remuneration and material personal interests. An election has recently been completed by the Australian Electoral Commission (**AEC**) for the National Tertiary Education Industry Union.

This letter explains the next steps you must take and what information you need to lodge with the Registered Organisations Commission (**ROC**).

**What you must do right now**

- Let your members know about the election report issued by the AEC
- Arrange financial training for officers newly elected to an office with financial management duties. (This includes all members of the committee of management).
- Complete the notification of change and email it to [regorgs@roc.gov.au](mailto:regorgs@roc.gov.au)

This letter explains these steps and the tools available to help you.

**STEP 1: Notify members**

You must put a notice on your website once you receive your post-election report. It must tell your members they can request a copy of the post-election report from you or the AEC (r. 141). The notice must be on your website for at least 3 months.



**Can I put more information on our website?**

Yes! Being transparent is part of good governance. You can publish the whole report or the declaration of results, as well as your notice and leave them up longer than 3 months. You can always do more than the regulatory minimum.

The ROC will also publish your declaration of results on our [website](http://www.roc.gov.au).

**STEP 2: Financial training**

You may have to arrange financial training for people elected to new roles.

All officers with financial management duties must complete financial training (s 293K). For information on when officers must redo training and hints on when to book training for officers taking up multiple offices [please see our fact sheet](#).

There are face to face and online [financial training packages on the ROC website](#).

You must act on this now, as affected officers **MUST** complete approved financial training OR been granted an [exemption by the ROC within 6 months](#) of beginning to hold office.

I, **Matthew McGowan**, General Secretary of the National Tertiary Education Industry Union, hereby request, pursuant to Section 189 of the Fair Work (Registered Organisations) Act 2009, that the General Manager arrange for the conduct of this organisation's elections in 2020:

1. Elections are required for those offices specified in the attached table, Attachment B.
2.
  - (a) **The name of each office** (Regulation 138(1)(a)) is specified in the first and second columns of Attachment B.
  - (b) **The reason for the election** (138(1)(b)) is as specified in the fifth column of Attachment B, according to the Key to Election Request which is at the Annexure to Attachment B.
  - (c) **Where more than one of the offices in respect of which an election is required have the same name** (138(1)(c)) the number of such offices is as specified in the third column of Attachment B, headed "No. Required".
  - (d) **The electorate from which each office is to be elected** (138(1)(d)) is as indicated in the fourth column of Attachment B, headed "Elected By", read in conjunction with the Annexure to Attachment B.
  - (e) **The voting system to be employed** (138(1)(g)) in the conduct of the election is as indicated in the sixth column of Attachment B read in conjunction with the Annexure to Attachment B.
  - (f) **The period during which nominations may be called** (138(1)(e)) is 1 March 2022, to such date as would see the elections declared before the terms of office commence, except that no time is prescribed by the rules in relation to new positions. To be determined by the returning officer.
3. The terms of office for each office in the attached table is two years, except that it is four years for the positions of Division Secretary in Queensland and Victoria, which are designated as full-time offices (Rule 69.8). No election is required for Division Secretary in the Australian Capital Territory, New South Wales, South Australia and Western Australia, which have four-year terms from 2020.
4. I have included in Attachment B in the left hand column in respect of each Branch where it is relevant in determining the number of National Councillors a Branch is to elect, the number of members of the Branch (Rule 18.1). This number is in brackets – e.g. ("897"). The listed number is based, as required by the rules, on the membership numbers according to the best records held by the General Secretary as at 28 February 2022 (Rule 18.1).



5. Specifically, you will note that the Victorian TAFE Branch has a National Councillor to be elected and the ACE and Companies Branch has a National Councillor to be elected, pursuant to the terms of Sub-Rule 18.3. In both cases, these are Branches established in respect of a sector.
6. **The date provided for in the rules as the day on which the roll of voters is to be closed (138(1)(f)) is the seventh day before the date determined for the opening of nominations (72.1).**
7. In accordance with Rule 18.3 I, an election is only requested for the position of Aboriginal & Torres Strait Islander Branch Committee Member at those Branches where, according to the Union's records today, the Union has Indigenous members. I have caused the records of the Union to be checked in respect of each Branch and the requests corresponds to the result of that check.
8. Other than the ANU Branch, I can confirm that each of the entities entitled to elect an Additional Divisional Councillor in the ACT Division each has less than 400 members.
9. I can confirm that the University of Tasmania Branch continues to be the only Branch in Tasmania.
10. As per rule 27.14 there are no Branches of the Union established in the Northern Territory and the Division Officers and Division Council in the Northern Territory Division shall be as set out in this sub-rule
11.
