IMMEDIATE ACTION REQUIRED:
You must take steps after your recent election E2022/25

Dear Andrew Smith,

An election has recently been completed by the Australian Electoral Commission (**AEC**) for the CPSU, the Community and Public Sector Union-SPSF Group, Western Australian Prison Officers' Union Branch.

This letter explains the next steps you must take and what information you need to lodge with the Registered Organisations Commission (**ROC**).

What you must do right now

- Let your members know about the election report issued by the AEC
- Arrange financial training for officers newly elected to an office with financial management duties. (This includes all members of the committee of management).
- Complete the notification of change and email it to regorgs@roc.gov.au

This letter explains these steps and the tools available to help you.

STEP 1: Notify members

You must put a notice on your website once you receive your post-election report. It must tell your members they can request a copy of the post-election report from you or the AEC (r. 141). The notice must be on your website for at least 3 months.



Can I put more information on our website?

Yes! Being transparent is part of good governance. You can publish the whole report or the declaration of results, as well as your notice and leave them up longer than 3 months. You can always do more than the regulatory minimum.

The ROC will also publish your declaration of results on our [website](https://www.roc.gov.au).

STEP 2: Financial training

You may have to arrange financial training for people elected to new roles.

All officers with financial management duties must complete financial training (s 293K). For information on when officers must redo training and hints on when to book training for officers taking up multiple offices [please see our fact sheet](#).

There are face to face and online [financial training packages on the ROC website](#).

You must act on this now, as affected officers **MUST** complete approved financial training OR been granted an [exemption by the ROC within 6 months](#) of beginning to hold office.



Good governance tip:

Organisations should instruct officer holders about their other obligations. This is especially important for committee of management members.

Officers have responsibilities under the rules, the RO Act, and disclosure requirements around conflicts of interest, remuneration and material personal interests. STEP 3: Notifications of change

A notification of change must be lodged with the ROC within **35 days** of the change occurring.



We have a [template](#) to help you with this, which you can send to regorgs@roc.gov.au. An officer must sign the completed notification template.

You must lodge a notification of change if:

- any of your officers have not been re-elected;
- officers have changed offices; or
- you have new officers.

Only notify us of changes that have **already occurred**. If people take up office in the future, you must wait until the change happens before lodging the notification within 35 days of the change.

Note: One election may result in many notifications of change.



Penalties apply

Failing to lodge your notifications of change on time can expose your organisation and its officers to significant penalties.

ROC v CEPU

The organisation failed to make a series of notifications of change on time.

The Full Court said 'The record-keeping obligations imposed under the Registered Organisations Act are treated by the legislature as important and serious, and contravention of those obligations are correspondingly serious.'

The organisation was ordered to pay a penalty. More information is available in our [case summary](#).

Why do I need to tell you the results of the election when you've already received them?

The RO Act requires that **you** tell us this information about your officers – it is a legal obligation. The notification of change also contains information that is not in the declaration of results.

What if the officer has already done training?

Fair Work (Registered Organisations) Act 2009
s.189—Arrangement for conduct of an election

CPSU, the Community and Public Sector Union (E2022/25)

MR STEENSON

SYDNEY, 1 JUNE 2022

Arrangement for conduct of election.

[1] On 3 May 2022, the Western Australian Prison Officers' Union Branch of the SPSF Group (the **WAPOU Branch**) of the CPSU, the Community and Public Sector Union (the **CPSU**), lodged with the Registered Organisations Commission (the **Commission**) prescribed information, and on 13 May and 20 May 2022 lodged amended prescribed information, for a scheduled election to fill the following offices for a new term of office:

[2] Further to the above offices, the Branch also lodged with the Commission prescribed information to fill the following offices for the remainder of their current term of office due to insufficient nominations received in the most recent scheduled election for these particular offices (**E2020/39**):¹

[3] There are a number of issues that arise in this matter, including in relation to the timing of the lodgement of prescribed information (including an apparent previous non-lodgement) and the Branch's understanding of when particular offices are due for election under the rules.

Election for Federal offices

[4] As will be evident from the list of offices above, the offices to be elected in this election (**E2022/25**) include Federal Council Delegates and a Branch Representative to the Federal Executive.

[5] The number of Federal Council Delegates representing the Branch is determined based on the Branch's financial membership as at 31 December in the year immediately preceding the election.² According to the Branch's membership at 31 December 2021, the Branch is entitled to four Federal Council Delegates. Of these, one Federal Council Delegate position is reserved for the Branch Secretary (ex-officio), and one Federal Council Delegate position is the Branch Representative to the Federal Executive elected by and from the Branch Council.³

Expectation of compliance with rules as they apply to election timetables

[6] In accordance with the Commission's usual practice, the prescribed information for this election has been assessed with reference to the CPSU Chapter C - SPSF Group Rules (**Chapter C rules**) and Schedule B to those rules (**the WAPOU Branch rules**), as well as considering previous elections for the relevant offices. In that assessment, Commission staff have identified that the most recent scheduled election for Federal offices – i.e. Federal Council Delegates, Federal Vice-President and Branch Representative to the Federal Executive, (all of which had a four year term under the rules)⁴ – was election E2016/196,⁵ declared by the Australian Electoral Commission (the **AEC**) in October 2016.

[7] Since that election, alterations to the Chapter C rules were certified by the Fair Work Commission in March 2019.⁶ Among other things, the amended rules introduced a provision whereby the elected Branch Secretary also held the office of Federal Vice-President and was a Federal Council Delegate ex-officio (i.e. by virtue of being Branch Secretary).

[8] Section 145 of the *Fair Work (Registered Organisations) Act 2009 (RO Act)* requires the rules of an organisation to provide for terms of office of no longer than 4 years without re-election.⁷ The Chapter C election rules provide that the Federal Offices referred to have a four-year term.⁸

[9] In response to the queries from Commission staff, the Branch has confirmed that no further scheduled election for Federal Offices has been conducted since election **E2016/196** was declared. That is, some offices have not been the subject of election for six years. The Branch also stated that its understanding was that the officers declared elected under **E2016/196** continued to hold office. The Branch's view in that regard is reflected in the CPSU's most recent Annual Return (AR2022/23) lodged on 18 March 2022, which lists persons elected to Federal offices in 2016 as current officers. If that approach (to have persons remain in office without further election) was accepted, it would be contrary to the provisions in the RO Act about the length of a single term.

[10] The exception to this relates to one office of Federal Council Delegate and the office of Federal Vice-President (which are now held ex-officio by the Branch Secretary under the rules), both offices which were previously held by the former Branch Secretary, John Welch (elected under E2016/196), who resigned from those offices in February 2018.

[11] A casual vacancy election to fill the vacancies for the offices of Federal Council Delegate and Federal Vice-President arising from the resignation of Mr Welch, was conducted at the same time as the scheduled election for Branch offices held under **E2018/38**.⁹ Notifications of change to offices lodged by the WAPOU Branch¹⁰ confirm that the dates of change of the office holder for both these offices, occurred in 2018.

[12] The Branch has advised that it incorrectly assumed that "as the casual vacancies arising from the resignation of John Welch resulted in an election for some of the Federal Officer roles in 2018, that the next scheduled election for these roles would be 2022 and not 2020" and that, as a result, WAPOU did not include these in the prescribed information lodged in 2020. This assumption appears to have been held despite the fact that the election decision issued for E2018/38 expressly stated that the election was to fill casual vacancies for the remainder of term, and that the applicable casual vacancy provision under the Chapter C rules specified that:

‘Any person so elected or appointed shall hold office *for the unexpired portion* of the term of the person he or she is elected or appointed to replace.’¹¹

[13] If the Branch had complied with the prescribed election cycle for Federal offices under the Chapter C rules, a scheduled election for Federal offices - Federal Council Delegates and the Branch Representative to Federal Executive - (noting that the office of Federal Vice-President is now held ex-officio by the Branch Secretary), should have occurred in 2020.

The failure to hold the election for Federal Offices within the required period, indicates an apparent lack of understanding of relevant election related rules and of the obligation to lodge prescribed information in accordance with the RO Act, and the Chapter C and WAPOU Branch

rules. The failure to lodge prescribed information in 2020 for these offices before the prescribed day exposes the CPSU to liability under section 189(2) of the RO Act.

[14] I also note that this Commission has issued a range of guidance material for registered organisations in relation to elections, reminding them of the need to lodge prescribed information if their rules state that an election is due.

Request for extension of time

[15] Section 189(2) of the RO Act requires that prescribed information be lodged before the ‘prescribed day’. The *Fair Work (Registered Organisations) Regulations 2009 (Regulations)*, in particular regulation 138(3) of the Regulations defines the ‘prescribed day’ as the day occurring ‘2 months before the first day when a person may, under the rules of the organisation or branch, become a candidate in an election’. In other words, it must be lodged at least two months before the date on which nominations open. Section 189(2) of the RO Act is a civil penalty provision and late lodgement can therefore leave an organisation open to litigation and potentially liable to a penalty.

[16] The Branch did not lodge the prescribed information before the prescribed day as required by the Regulations. While the Chapter C rules do not specify a prescribed day, rule 19.1 of the Chapter C rules provides that the first stage of the election (i.e. the election for Branch offices and Sub-Branch Council Delegates) are to be conducted so that a result is declared not earlier than 1 May and not later than 30 June in the election year. Using the latest possible date specified in the rules for declaring the result of the election (i.e. 30 June) and working back from that, i.e. allowing a period for the opening and closing of nominations and for a ballot to be conducted if required, it is clear that the prescribed information should have been lodged considerably earlier than it was. The lengthy delay in lodging prescribed information for this election was such that even if 30 June had been the specified date on which nominations were to open (as distinct from the last day that the result could be declared), the lodgement would still be late.

[17] By letter dated 13 May 2022, the Branch Secretary, Mr Smith, advised that the delay in lodgement of prescribed information in the current matter was due to:

- the Branch Secretary being the only full-time paid Branch official who in carrying out his duties is assisted by the Branch President, a prison officer who works on a shift basis;
- the Branch President having been absent due to illness and as a consequence, the Branch Secretary’s own administrative and industrial workload having increased;
- an apparently increasing level of industrial disputation and consequent demands on the Branch Secretary’s time to attend to industrial issues;
- reasons including the impact of the Covid-19 pandemic and staff leave arrangements, meaning that the Branch’s administrative staff members, who are normally responsible for the preparation and lodgement of documents with the Commission, not being available to undertake these duties, and that consequently the Branch Secretary has had to personally prepare and lodge the prescribed information for this election;

[18] The Branch Secretary submitted that these are exceptional circumstances which have resulted in the Branch’s failure to lodge the prescribed information within a timeframe to enable

the election process to be completed within the period referred to in rules 19.1 and 32.2 of the Chapter C rules.

[19] The Branch has requested that the Commissioner (or his Delegate) exercise his power under section 189(2) of the RO Act to allow a later date for lodgement of the prescribed information.

[20] In reviewing the Branch's history of lodgements of prescribed information, I note that there has already been a pattern of late lodgements (such as in elections **E2016/196**,¹² **E2017/210**¹³ and **E2020/39**¹⁴), apparently due to administrative oversight, and in the case of the prescribed information required to be lodged in the 2020 scheduled election, the Branch's belief that the AEC's restrictions in holding elections during the Covid-19 pandemic provided the Branch with more time to lodge its prescribed information.¹⁵ I also note that in these previous elections in which the Branch has failed to lodge prescribed time within the prescribed time, the Commission has refused to grant an extension of time to lodge the prescribed information in two of those three instances.¹⁶

[21] This is therefore the fourth time in recent history that the Branch has failed to lodge prescribed information on time. This is in addition to there being no lodgement of prescribed information for Federal offices in 2020.

[22] In those previous election decisions in respect of this Branch, Delegates of the Commissioner have emphasised that the normal and reasonable expectation is that registered organisations and their branches take steps to ensure that they comply with the timeframe requirements set out not only in the RO Act but also in the rules of the organisation, (which the organisation itself has formulated.) In the 2020 election decision (**E2020/39**), it was noted that "the lodgement of the prescribed information with the Registered Organisations Commission on 18 May 2020 would not allow for the results to be declared in the timeframe contemplated by the rules".¹⁷

[23] It could reasonably be expected that, following these three decisions in which the issue of late lodgement was highlighted and in which, in two of those matters, a later date for lodgement was not allowed, that the Branch would take steps to remedy any of the apparent 'administrative' deficiencies that resulted in the late lodgement. Unfortunately, this does not appear to have been the case and, as indicated above, the current late lodgement was accompanied by details of further reasons for delay.

[24] While I do not doubt the veracity of the reasons for delay set out by the Branch Secretary in his 13 May 2022 letter, I am not satisfied that these reasons are sufficient ground to justify the failure to comply with a statutory obligation. I decline on this occasion to allow, under section 189(2) of the Act, a later day for lodgement. I draw attention to the fact that the failure to lodge before the prescribed day exposes the organisation to liability under a civil penalty provision, pursuant to section 189(2) of the RO Act.

[25] I also draw attention to the matter of *Registered Organisations Commission v Australian Hotels Association*,¹⁸ in which the Federal Court imposed substantial penalties on a registered organisation which had contravened section 189(2) of the RO Act on multiple occasions. The Commission will engage further with the WAPOU Branch and the CPSU in relation to the recurrent late lodgement of prescribed information that in relation to the Branch, which leaves the organisation open to civil penalties.

[26] The refusal of an extension of time under section 189(2) of the RO Act does not however affect the requirement to conduct an election under section 189(3) of the RO Act.

[27] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the AEC.
