#### **IMMEDIATE ACTION REQUIRED:**

You must take steps after your recent election E2022/120

An election has recently been completed by the Australian Electoral Commission (AEC) for the Transport Workers' Union of Australia.

This letter explains the next steps you must take and what information you need to lodge with the Fair Work Commission (the Commission).

#### What you must do right now

- Let your members know about the election report issued by the AEC
- Arrange financial training for officers newly elected to an office with financial management duties. (This
  includes all members of the committee of management).
- Complete the notification of change and email it to regorgs@fwc.gov.au

This letter explains these steps and the tools available to help you.

### **STEP 1: Notify members**

You must put a notice on your website once you receive your post-election report. It must tell your members they can request a copy of the post-election report from you or the AEC (regulation 141). The notice must be on your website for at least three months.



#### Can I put more information on our website?

Yes! Being transparent is part of good governance. You can publish the whole report or the declaration of results, as well as your notice and leave them up longer than three months. You can always do more than the regulatory minimum.

The Commission will also publish your declaration of results on our website.

#### **STEP 2: Financial training**

You may have to arrange financial training for people elected to new roles.

All officers with financial management duties must complete financial training (section 293K). For information on when officers must redo training and hints on when to book training for officers taking up multiple offices please see our fact sheet.

There are face to face and online financial training packages on the Commission website.

You must act on this now, as affected officers MUST complete approved financial training OR been granted an <a href="mailto:exemption.org">exemption by the Commission</a> within six months of beginning to hold office.



#### **Good governance tip:**

Organisations should instruct officer holders about their other obligations. This is especially important for committee of management members.

## **STEP 3: Notifications of change**



A notification of change must be lodged with the Commission within **35 days** of the change occurring.

We have a <u>template</u> to help you with this, which you can send to <u>regorgs@fwc.gov.au</u>. An officer must sign the completed notification template.

You must lodge a notification of change if:

- any of your officers have not been re-elected;
- · officers have changed offices; or
- you have new officers.

Only notify us of changes that have **already occurred.** If people take up office in the future, you must wait until the change happens before lodging the notification within 35 days of the change.

Note: One election may result in many notifications of change.



#### **Penalties apply**

Failing to lodge your notifications of change on time can expose your organisation and its officers to significant penalties.

#### **ROC v CEPU**

The organisation failed to make a series of notifications of change on time.

The Full Court said 'The record-keeping obligations imposed under the Registered Organisations Act are treated by the legislature as important and serious, and contravention of those obligations are correspondingly serious.'

The organisation was ordered to pay a penalty. More information is available in our <u>case</u> summary.



## Why do I need to tell you the results of the election when you've already received them?

The RO Act requires that **you** tell us this information about your officers – it is a legal obligation. The notification of change also contains information that is not in the declaration of results.

#### What if the officer has already done training?

- [2] The organisation noted in its prescribed information that a rule alteration has been lodged with the Fair Work Commission (FWC) and is pending certification. The alteration, if certified by the FWC, would allow a candidate for the position of National Secretary and a candidate for the position of National Assistant Secretary to agree to run as a 'National Team Nomination'. The proposed alteration also seeks to clarify who is eligible to run for office, and how candidates who withdraw or are otherwise excluded as part of a Team Nomination may be replaced.
- [3] The Australian Electoral Commission (AEC) should be aware that these rule alterations may be certified by the time the election process commences, and if so, the election would occur under the amended rules.
- [4] The organisation's rules also provide that, in respect of the office of Branch Assistant Secretary of the NSW/QLD (Interim Governance), the number of Branch Assistant Secretaries is determined by a Committee of Management resolution prior to the election for that office.<sup>2</sup> The organisation advised the Commission by email dated 5 August 2022 that, as the election for Branch Assistant Secretary is part of the collegiate stage of the NSW/Qld (Interim Governance) Branch elections, the newly elected Branch Committee of Management (elected in Stage 1 of these elections) will decide how many Branch Assistant Secretaries there will be. I note that it will need to do so before nominations can be called for that office, and will need to advise the AEC accordingly.
- [5] Further, a decision was issued in matter E2020/157 on 12 August 2020,<sup>3</sup> being a casual vacancy election for NSW Branch Vice President. As a result of communications from the organisation, I understand that the election E2020/157 has not yet been conducted. The effect of this decision (E2022/120) arranging for a scheduled election for a new term of office, is that

its conduct will supersede the decision in E2020/157. I confirm that the AEC is therefore no longer required to conduct election E2020/157.

[6] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the AEC.

It also seeks to clarify who is eligible to run for office. Finally it seeks to clarify how candidates who withdraw or are otherwise excluded as part of a Team Nomination may be replaced.
- 5. The original prescribed information was lodged on 13 July 2022 at least 2 months before nominations open for the election(s) in Annexure A. This second statement clarifies some outstanding matters in relation to the number of positions open for election in certain Branches as requested by the Registered Organisations Commission on 3 August 2022.
- 6. The following number of positions are determined in accordance with a formula:
  - Victorian/Tasmanian Branch National Councillor
  - South Australian/Northern Territory Branch National Councillor
  - Western Australian Branch National Councillor

- b. The formula is total income received from Members through Dues divided by the Annual Fee in the previous year.

- South Australian/Northern Territory Branch \$1,596,223 received from members in Dues divided by \$560.58 resulting in 2,847 Effective Members entitling the Branch to no additional National Councillors.
- Western Australian Branch \$3,622,903 received from members in Dues divided by \$560.58 resulting in 6,463 Effective Members entitling the Branch to two additional National Councillors.
- d. The relevant date for this information is 31 December 2021.
