You must take steps after your recent election E2022/179

Dear Bernie Hogan,

An election has recently been completed by the Australian Electoral Commission (**AEC**) for the Australian Hotels Association - Queensland Branch.

This letter explains the next steps you must take and what information you need to lodge with the Registered Organisations Commission (**ROC**).

What you must do right now

- Let your members know about the election report issued by the AEC
- Arrange financial training for officers newly elected to an office with financial management duties. (This includes all members of the committee of management).
- Complete the notification of change and email it to regorgs@roc.gov.au

This letter explains these steps and the tools available to help you.

STEP 1: Notify members

You must put a notice on your website once you receive your post-election report. It must tell your members they can request a copy of the post-election report from you or the AEC (r. 141). The notice must be on your website for at least 3 months.



Can I put more information on our website?

Yes! Being transparent is part of good governance. You can publish the whole report or the declaration of results, as well as your notice and leave them up longer than 3 months. You can always do more than the regulatory minimum.

The ROC will also publish your declaration of results on our website.

STEP 2: Financial training

You may have to arrange financial training for people elected to new roles.

All officers with financial management duties must complete financial training (s 293K). For information on when officers must redo training and hints on when to book training for officers taking up multiple offices <u>please see our fact sheet</u>.

There are face to face and online financial training packages on the ROC website.

You must act on this now, as affected officers MUST complete approved financial training OR been granted an <u>exemption by the ROC</u> within 6 months of beginning to hold office.



Good governance tip:

Organisations should instruct officer holders about their other obligations. This is especially important for committee of management members.

Our podcast covers the <u>benefits of officer induction</u>. Officers have responsibilities under the rules, the RO Act, and disclosure requirements around conflicts of interest, remuneration and material personal interests. Officers will benefit from our <u>officer induction kit</u> and our <u>podcast</u>, such as episode 17 - conflicts of interest.

STEP 3: Notifications of change

A notification of change must be lodged with the ROC within **35 days** of the change occurring.



We have a <u>template</u> to help you with this, which you can send to <u>regorgs@roc.gov.au</u>. An officer must sign the completed notification template.

You must lodge a notification of change if:

- any of your officers have not been re-elected;
- officers have changed offices; or
- you have new officers.

Only notify us of changes that have **already occurred.** If people take up office in the future, you must wait until the change happens before lodging the notification within 35 days of the change.

Note: One election may result in many notifications of change.



Penalties apply

Failing to lodge your notifications of change on time can expose your organisation and its officers to significant penalties.

ROC v CEPU

The organisation failed to make a series of notifications of change on time.

The Full Court said 'The record-keeping obligations imposed under the Registered Organisations Act are treated by the legislature as important and serious, and contravention of those obligations are correspondingly serious.'

The organisation was ordered to pay a penalty. More information is available in our <u>case summary</u>.

Why do I need to tell you the results of the election when you've already received them?

The RO Act requires that **you** tell us this information about your officers – it is a legal obligation. The notification of change also contains information that is not in the declaration of results.

What if the officer has already done training?

Check out our <u>fact sheet</u> for when officers need to redo training, when they can get an exemption and when further training isn't required.

Other Matters

Returning Officer actions required (Section 193): Yes Details:

- The rules of the Organisation states that the nominations are required to be called at least two months prior to the Annual General Meeting. Due to a delay in the PI submission, the issuing of the Decision and Covid-19 work pressures, the rule could not be complied with. The Returning Officer will apply subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 and will fix a date to call for nominations.
- Rules requiring an in-person declaration at the Annual General Meeting were set aside as the AEC held concerns that the coronavirus pandemic would impact on the ability for all stakeholders to attend. Instead the declaration will be made via email to the organisation and candidates.
- The rules of the Organisation is silent about the method of calling for nomination. The Returning Officer will apply subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 and will send the election notice by email to divisional members.
- The rules of the Organisation is silent about the nomination lodgement method. The Returning Officer will apply subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 and will allow submission of nomination by email and AEC Portal.
- As there is no rule pertaining to the withdrawal of Nomination, the Returning Officer will apply subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to fix a closing time for the withdrawal of nomination and the withdrawal period will align with the close of the nomination period.
- Rule of the Organisation states that the maximum ballot period will not be more than 14 days. The Returning Officer will apply subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to extend the period due to current delivery time taken by Australia post and will allow 28 days instead of 14 days.

Arrangement for conduct of election.

[1] On 16 September 2022 the Queensland Branch of the Australian Hotels Association (**Branch**) lodged with the Registered Organisations Commission (**Commission**) prescribed information for an election to fill the following offices for a new term of office:

[2] Prescribed information, which is required to be lodged in order for an election to be arranged, must be lodged at least two months before the date that nominations are due to open under the rules. This is known as the 'prescribed day'.¹ In relation to this election, the prescribed information should have been lodged by 6 August 2022. As will be apparent from the date of lodgement referred to in paragraph 1 of this decision, the Branch did not lodge before the prescribed day as required. As the Branch is well aware, late lodgement or non-lodgement of prescribed information is a contravention of a civil penalty provision of the *Fair Work* (*Registered Organisations*) Act 2009 (**RO Act**).²

[3] In correspondence from the Branch dated 6 October 2022, the Branch President stated that the delay was due to rule changes pending with the Fair Work Commission (FWC). These rule changes, if certified, would have the effect of removing the abovementioned offices. The Branch advised this Commission that once it became apparent that certification of the proposed rule changes was not imminent, the Branch lodged prescribed information for this election to be conducted.

[4] Section 189 of the RO Act enables the Commissioner or their Delegate to allow a later day for lodgement of prescribed information. In considering the Branch's request that such an extension in time be granted, I note that the Branch apparently had the expectation that these offices would no longer exist by the time the election was due. However, the Commission also notes that there was a period of several months between the lodgement of rule changes and the date that prescribed information was due, during which the Branch could have taken steps to better ascertain the timeframe on the rule certification, and therefore potentially avoid this noncompliance.

[5] In taking into account the circumstances and considering the Branch's request for an extension of time, on this occasion I allow a later day for lodgement under section 189(2) of the RO Act.

[6] Further, while it appears that the rule changes may not be certified before this election is conducted, I draw to the attention of the Australian Electoral Commission (AEC) that these rule changes are pending and, if certified before the election, would significantly affect this election (possibly to the point of the rule changes overtaking the need for the election). In these circumstances, I urge the Branch to advise this Commission and the AEC immediately when it becomes aware of the certification of the rule changes.
