Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Victorian Farmers Federation Industrial Association (E2023/106)

Arrangement for conduct of election.

[1] On 23 May 2023 the Victorian Farmers Federation Industrial Association (VFFIA) lodged with the Fair Work Commission prescribed information for an election to fill the following offices:

Executive Committee Member	(6)
President	(1)
Vice-President	(1)
Treasurer	(1)

[2] By letter dated 2 May 2023, the VFFIA foreshadowed to the Commission that, at meetings proposed for September this year, the question of whether to cancel or maintain its registration will be considered. I note that if the organisation did resolve to cancel its registration, the steps required by the *Fair Work (Registered Organisations) Act 2009* (RO Act) – such as passing a resolution to apply for cancellation of registration, subsequently making that application, consideration and gazettal of the application for a specified period, considering any objections and then a member of the Commission determining the application – it would be several months after any decision by the organisation before it would take effect. In the meantime, the organisation is required to comply with the requirements imposed on it as a registered organisation.

[3] I note that the Commission's records indicate that in April 2022 a representative of the VFFIA advised the then-regulator, the Registered Organisations Commission that (a) the previous election had been delayed from 2020 (due to delays in the conduct of elections associated with COVID-related restrictions) and had only been declared in 2021, and (b) the organisation was looking at cancelling its registration at that time. No cancellation application was made in 2022.

[4] A registered organisation is required to conduct elections for office in certain circumstances. Commission staff have advised the organisation that it is not open to the

Commission to exempt an organisation from the requirement to hold elections. Having considered the time that had elapsed since the last VFFIA election was declared by the Australian Electoral Commission (AEC) and the election requirements set out in the organisation's rules, on 10 May 2023 this Commission wrote to the VFFIA seeking lodgement of prescribed information. I acknowledge the organisation's attention in ensuring that the lodgement was then made.

[5] Section 189(2) of the RO Act requires that prescribed information be lodged at least two months before the date that nominations are due to open according to an organisation's rules. However, the General Manager or his authorised Delegate may allow a later date for lodgement. On this occasion, I allow such later date.

[6] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the AEC. This will ensure that the VFFIA meets its current election-related obligations during the period that its registration continues.
