

Can I put more information on our website?

Yes! Being transparent is part of good governance. You can publish the whole report or the declaration of results, as well as your notice and leave them up longer than three months. You can always do more than the regulatory minimum.

The Commission will also publish your declaration of results on our website.

STEP 2: Financial training

You may have to arrange financial training for people elected to new roles.

All officers with financial management duties must complete financial training (section 293K). For information on when officers must redo training and hints on when to book training for officers taking up multiple offices please see our fact sheet.

There are face to face and online financial training packages on the Commission website.

You must act on this now, as affected officers MUST complete approved financial training OR been granted an exemption by the Commission within six months of beginning to hold office.

A notification of change must be lodged with the Commission within **35 days** of the change occurring.

You must lodge a notification of change if:

- any of your officers have not been re-elected;
- · officers have changed offices; or
- you have new officers.

Only notify us of changes that have **already occurred.** If people take up office in the future, you must wait until the change happens before lodging the notification within 35 days of the change.

Note: One election may result in many notifications of change.



Penalties apply

Failing to lodge your notifications of change on time can expose your organisation and its officers to significant penalties.

ROC v CEPU

The organisation failed to make a series of notifications of change on time.

The Full Court said 'The record-keeping obligations imposed under the Registered Organisations Act are treated by the legislature as important and serious, and contravention of those obligations are correspondingly serious.'

The organisation was ordered to pay a penalty. More information is available in our <u>case</u> summary.



Why do I need to tell you the results of the election when you've already received them?

AMENDING DECISION

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Australian Hotels Association

(E2022/180)

SYDNEY, 10 FEBRUARY 2023

Arrangement for conduct of election.

- [1] On 12 October 2022, as Delegate of the Registered Organisations Commissioner, I issued a decision in this matter, [2022] ROCD 154. In that original decision, among the offices for which an election was to be arranged was that of Zone General Committee Representatives from each of the Divisions in the Southern Zone.
- [2] On 9 February 2023, it was brought to the Commission's attention that while the prescribed information sought the election of two (2) Zone General Committee Representatives from the Ipswich Division, my 12 October 2022 decision inadvertently omitted one of those two offices.
- [3] As I am satisfied that an election is also required for that previously omitted office, as well as the offices listed in the original 12 October 2022 decision, [2022] ROCD 154, is amended as follows:


By removing the number '(1)' and inserting the number '(2)' as the number of offices of 'Zone General Committee Representatives' from the Ipswich Division on page 2 of that decision.

Arrangement for conduct of election.

[1] On 16 September 2022 the Queensland Branch of the Australian Hotels Association (**Branch**) lodged with the Registered Organisations Commission (**Commission**) prescribed information for an election to fill the following offices for a new term of office:

[2] Prescribed information, which is required to be lodged in order for an election to be arranged, must be lodged at least two months before the date that nominations are due to open under the rules. This is known as the 'prescribed day'. In relation to this election, the prescribed information should have been lodged by 17 July 2022. As will be apparent from the date of lodgement referred to in paragraph 1 of this decision, the Branch did not lodge before the prescribed day as required. As the Branch is well aware, late lodgement or non-lodgement of prescribed information is a contravention of a civil penalty provision of the RO Act.²

[3] In its correspondence dated 6 October 2022, the Branch President stated that the delay was due to rule changes pending with the Fair Work Commission (FWC). These rule changes, if certified, would have the effect of removing the abovementioned offices. The Branch advised this Commission that once it became apparent that certification of the proposed rule changes was not imminent, the Branch lodged prescribed information for this election to be conducted.

[4] Section 189 of the Fair Work (Registered Organisations) Act 2009 (RO Act) enables the Commissioner or their Delegate to allow a later day for lodgement of prescribed information. In considering the Branch's request that such an extension in time be granted, I note that the Branch apparently had the expectation that these offices would no longer exist by the time the election was due. However, the Commission also notes that the Branch has a history of late lodgement, and that there was a period of several months between the lodgement of rule changes and the date that prescribed information was due, during which the Branch could have taken steps to better ascertain the timeframe on the rule certification, and therefore potentially avoid this non-compliance.

[5] In taking into account the circumstances and considering the Branch's request, on this occasion I allow a later day for lodgement under section 189(2) of the RO Act.

- [6] Further, while it appears that the rule changes may not be certified before this election is conducted, I draw to the attention of the Australian Electoral Commission (AEC) that these rule changes are pending and, if certified before the election, would significantly affect this election (possibly to the point of the rule changes overtaking the need for the election). In these circumstances, I urge the Branch to advise this Commission and the AEC immediately when it becomes aware of the certification of the rule changes.
- [7] I also note that the Branch rules contain contradictions in relation to the length of the term for the abovementioned offices. For example, rule 50(e) outlines that the elections will take place each year, whereas rule 50(f) indicates that the election will take place every 2 years.
- [8] Historically, the Branch has held an election for these offices every year. The Branch should strongly consider amending its rules to remove these contradictions and I anticipate that this Commission will engage further with the Branch in this regard. I note, however, that if the proposed rule changes submitted to the FWC are certified, this may have the effect of removing the contradictions simply because it removes these offices completely.
- [9] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the AEC.
