The said notice correctly advised that Robert Shelley had resigned from two offices but incorrectly stated that both offices were vacant with effect on 24 October 2024.

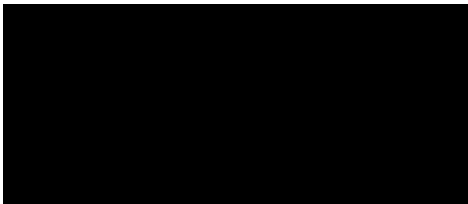
