Your primary review

I, Tony Hopkins, being the Chairperson of the Australian Public Transport Industrial Association, declare the following:

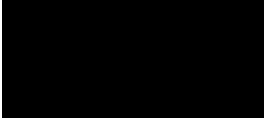
1. I am authorised to make this declaration.
