Arrangement for conduct of election.

- [1] On 24 June 2024, I issued a decision in matter **E2024/100** as Delegate of the General Manager of the Fair Work Commission (the **Commission**) arranging for an election for the New South Wales Teachers Federation Branch (the **Branch**) of the Australian Education Union (the **AEU**) for the offices of Branch Council representatives.
- [2] On 26 November 2024, the Branch lodged prescribed information relating to the election of **Alternative Councillors** on Branch Council. Such Alternative Councillors are elected (if required) in accordance with sub rule 36(7) of the Branch rules. In the prescribed information, the General Secretary of the Branch declared that sub rule 36(7)(b) operated such that Alternative Councillors can only be identified after nominations close or when elections are counted, with the Returning Officer determining the number of Alternative Councillors who are 'the next person or persons elected after the association representatives, or the representatives elected by and from the members on the ATSI Members' Roll, as the case may be...'.
- [3] I am satisfied that the Branch rules operate such that offices of Alternative Representatives for various Associations, Groups of Associations and members on the ATSI Members' Roll may be declared elected in accordance with sub rule 36(7) and that this cannot be fully determined until after the ballot count has been undertaken.
- [4] I am also satisfied that, as part of the Branch's election process, 'Alternative Councillors numbers to be determined in accordance with sub rule 36(7)' are required, and I request that the Australian Electoral Commission make arrangements accordingly.

- [2] I note that rule 36(7)(a) of the Branch rules provides that the Returning Officer shall, in consultation with the relevant Association, Group of Associations or members on the ATSI Members' Roll (as the case may be), determine the number of alternative Association representatives to be elected respectively by the Association, Group of Associations or members of the ATSI Member's Roll (as the case may be). It is expected that the Branch will lodge further prescribed information in relation to these elections at a future date.
- [3] On 15 and 16 July 2024, Commission staff contacted the organisation seeking further clarification in relation to a number of apparent errors in the Prescribed Information lodged with the application. These errors related to the current financial membership numbers within particular electorates, and the total number of offices required for this election from particular electorates. The organisation has since provided confirmation that the errors were of a typographical nature and has clarified the correct figures. I note, in particular, that for the electorate of the Association of 'Lake Wallis', the correct number of offices due for election is two (2).
- [4] Further to the issue outlined above, Commission staff also sought clarification in relation to the Association of 'Lakeside', for which an election had not previously been sought. The organisation confirmed this is a new Association, which was established via its separation from the existing Association of 'Lake Macquarie' (an electorate with a substantial number of financial members in the previous election of **E2022/87**). I note that rule 57 of the Branch rules allows for the Branch Council to authorise the formation and/or dissolution of an Association.
- [5] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.


