Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Arrangement for conduct of election.

[1] On 11 October 2024, the Flight Attendants' Association of Australia lodged with the Fair Work Commission prescribed information for an election to fill a casual vacancy in the following offices for the remainder of the term:

Assistant Federal Secretary (Domestic) (1)

Vice President (Domestic) (1)

- [2] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
- [3] In the event that any consequential casual vacancies arise from the filling of the offices listed above, those consequential vacancies would then need to be the subject of an election if the declaration of results is still within the first 12 months of the FAAA's 4 year term (which commenced on 30 June 2024).
