Arrangement for conduct of election.

- [1] On 1 November 2024 the Australian Workers' Union (**AWU**) lodged with the Fair Work Commission prescribed information for an election to fill the following offices under section 189 as well as a non-office position under section 187 of the *Fair Work* (*Registered Organisations*) Act 2009 (the Act), for a new term of office.
- [2] The list of offices is set out in **Attachment A**. The non-office position is set out in **Attachment B**.
- [3] For some of the offices, in particular Delegates to National Conference and National Executive, each Branch Secretary holds the role of Delegate by virtue of their office. On 6 December 2024, the AWU helpfully clarified the number of Delegates (additional to the Branch Secretary) to be elected by particular branches, as well as the name of one of the sub-branches listed in the prescribed information.
- [4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
