Arrangement for conduct of election.

[1] On 21 November 2024 the South Australian Branch of the Australian Education Union lodged with the Fair Work Commission prescribed information for an election to fill offices from the electorates listed in **Appendix A**, attached, for a new term of office:

General Division Delegates to Branch Council (106 in total)
General Division Alternate Delegates to Branch Council (106 in total)

- [2] The rules provide that these offices are elected by and from General Division members, ¹ in the areas specified in Appendix A, for a one-year term² with the election due for completion by 20 March.³
- [3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
