Arrangement for conduct of election.

[1] On 19 December 2024 the Civil Air Operations Officers' Association of Australia (**organisation**) lodged with the Fair Work Commission prescribed information for an election to fill the following offices for a new term of office:

Vice President Professional	(1)

[2] The rules of the organisation, in particular rule 38, provide that these offices are elected in each odd numbered year and take office from 1 May in the election year.

[3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

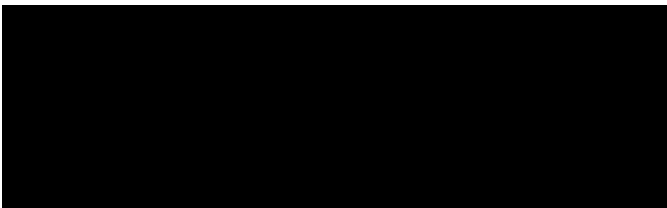

Elected by:

For the positions marked “A”, the electorate for the direct voting system is the entire membership.

Nominations open:

Nominations open in accordance with a timetable provided by the Returning Officer, delegated by the Australian Electoral Commission (AEC) - for the positions marked “A”, refer to Civil Air rule 35(d)(2)(b).

Nominations close:

Nominations close in accordance with a timetable provided by the Returning Officer, delegated by the Australian Electoral Commission (AEC) - for the positions marked “A”, refer to Civil Air rule 33(f)(i).

Cut off date for roll:

In all cases, 7 days prior to the opening date for nominations.
