Arrangement for conduct of election.

Branch Secretary

[1] On 31 March and 11 April 2025 the South Australian Branch (the **Branch**) of the SPSF Group of the CPSU, the Community and Public Sector Union (the **organisation**) lodged with the Fair Work Commission (the **Commission**) prescribed information for an election to fill the following offices for a new term of office:

- [2] I note that the previous election (**E2020/14**) was delayed due to issues related to the Covid-19 pandemic. As a result, in order to resynchronise the SPSF Group's Federal and Branch elections, a transitional rule was inserted in the SPSF Group's rulebook enabling the next election cycle to occur in 2025. The rule change had the effect of truncating the terms of office for the current Branch officers (who were elected via the late-running E2020/14) by one year. The next scheduled election for these offices is therefore due this year, with a three (3) year term of office. Under the rules, the terms of office will revert back to their original four (4) year duration from the 2028 election.
- [3] Having regard to the office of Delegates to Federal Council, rule 3.2(a) of the SPSF Group rules provides that the number of Delegates required for each Branch is to be calculated based on the number of financial members within the Branch in the year preceding the election. The Branch's initially-lodged prescribed information indicated that it is entitled to four (4) Delegates, based on its financial membership numbers as at 31 December 2024. By operation of rule 32.3(b) of the SPSF Group rules, one of the Delegate offices is to be held by the Branch Secretary, and another by the Branch Representative to the Federal Executive. As a result, an election is only required for the remaining two (2) Delegate offices.
- [4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

I, Natasha Brown, being the Branch Secretary of the CPSU SPSF Group South Australian Branch, am authorised to provide this amendment.

This amendment follows conversations with the FWC regarding clarification on the number of positions required by election for South Australian Branch Federal Council Delegates.

As stated in our previously submitted Prescribed Information, the CPSU SPSF Group SA Branch is entitled to 4 Federal Council Delegates.

As stated, 1 position is reserved ex officio for the Branch Secretary who will hold the office of Federal Vice President (Chapter C Part 3B Rule 32.3(b)(i)), and 1 position is reserved for the Branch Representative to Federal Executive (Chapter C Part 3B Rule 32.3(b)(ii)).

Therefore, while there are 4 positions available to the CPSU SPSF Group SA Branch, only 2 positions are required to be filled by a distinct collegiate election for those positions.

Please accept this as an amendment to the Prescribed Information on the number of positions required by election for South Australian Branch Federal Council Delegates supplied on 31 March 2025.

PRESCRIBED INFORMATION FOR ELECTIONS in accordance with Section 189 Fair Work (Registered Organisations) Act 2009 and Regulation 138 Fair Work (Registered Organisations) Regulations 2009

- I, Natasha Brown, being the Branch Secretary of the CPSU SPSF Group South Australian Branch make the following statement:
- 1. I am authorised to sign this statement containing prescribed information for the CPSU SPSF Group South Australian Branch.
- 2. The following information is lodged under subsection 189(1) of the Fair Work (Registered Organisations) Act 2009 (the RO Act).
- 3. The elections that are required are set out in the table in Annexure A.
- 4. No rule alterations are pending that will impact the election.
- 5. This statement **IS** lodged at least 2 months before nominations open for the elections in Annexure A.
- 6. The number of elected representatives is calculated on formulas defined in the CPSU SPSF Group Chapter C and the CPSU SPSF Group South Australian Branch rules:
 - a. CPSU SPSF Group Chapter C rules 3.2 (Federal Council Delegates) and 7.1 (Branch Council) and CPSU SPSF Group South Australian Branch rules 8 and 9 (Branch Council and Branch Electorates)
 - b. The rule numbers which specify the formulas are:

Federal Council Delegates

CPSU SPSF Group Chapter C Rule 3.2. The number of financial members in the Branch as at 31 December of the year preceding the election of Federal Council Delegates determines the number of delegates to be elected.

Branch Council Delegates

CPSU SPSF Group Chapter C Rule 7.1; and CPSU SPSF Group South Australian Branch Rule 8 provide for financial members to be allocated to Branch electorates on the basis of 1 Branch Council delegate per 500 members or part thereof. CPSU SPSF Group South Australian Branch Rule 9 describes the electorates.

c. The information for calculating the formulas is:

Federal Council Delegates

As at 31 December 2024 the total number of financial members of the CPSU SPSF Group South Australian Branch was 8,386. CPSU SPSF Chapter C Rule 3.2 (a) therefore entitles the South Australian Branch to 4 Federal Council delegates.
