Arrangement for conduct of election.

[1] On 28 March 2025 the SPSF Group of the CPSU, the Community and Public Sector Union (the **organisation**) lodged with the Fair Work Commission (the **Commission**) prescribed information for an election to fill the following offices for a new term of office:

Federal Secretary (1)

Federal President (1)

[2] On 6 December 2023, the Commission certified alterations to the rules of the organisation.¹ The changes, among other things, introduced a transitional provision (Rule 66) enabling the next election cycle to occur in 2025, with the object of resynchronising the election cycle for Federal Council offices, following delays as a consequence of the Covid-19 pandemic.

[3] The rule changes truncated the terms of office for the Federal Secretary and Federal President, which were most recently elected in 2022. As a result of the rule alterations, the next scheduled election for these offices is now due, with a three (3) year term of office. The terms of office revert back to their original four (4) year duration from the 2028 election.

[4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.



Please note that Rule changes in December 2023 have brought CPSU elections back into the same schedule (see Rule 66), including a transitional rule enabling truncated terms up to 2025-2028 cycle (3years) , due to elections that had been disrupted with the returning officer (AEC) being unable to complete all elections in a timely manner due to the COVID pandemic.
7. Please note that the timing of conduct of the election has also changed with these rules changes, requiring lodgement of this PI prior to 31 March, and enabling the FWC and AEC (returning officer) flexibility to determine the timing of the CPSU elections after the mandatory 2 months period from lodgement.
