Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

National Tertiary Education Industry Union (E2025/26)

Arrangement for conduct of election.

[1] On 28 February and 27 March 2025 the National Tertiary Education Industry Union (**organisation**) lodged with the Fair Work Commission (**Commission**) prescribed information for an election to fill the following vacancies for the remainder of the term, being casual vacancies, offices vacant due to insufficient nominations in a previous scheduled election (**E2023/176**) and new offices created under a transitional rule¹:

Division and Branch offices as set out in Attachment A

[2] In addition to the above request, the prescribed information also requested an election under section 187 of the *Fair Work (Registered Organisations) Act 2009* (**RO Act**) for the following non-office positions which are vacant due to insufficient nominations in the abovementioned previous election (**E2023/176**):

Sub Branch non-office positions as set out in **Attachment B**

- [3] It is noted that the Australian Electoral Commission (AEC) issued declarations of results for scheduled election E2023/176 from 10 July to 7 October 2024, and that several casual vacancies that are the subject of this decision arose before, during and after the conduct of that election.
- [4] The organisation has previously indicated to the Commission that it has a practice of holding one election each year for all insufficient nominations and casual vacancies. However, the rules of the organisation do not currently reflect this practice. As such, it has been recommended to the organisation that it consider enacting rule changes to confirm this practice. It appears that the organisation is yet to take this step and is strongly encouraged to do so.

This Branch has been created following the abolition of the University of Adelaide and the University of South Australia branches.

- [5] Commission staff also raised concerns with the organisation related to casual vacancies in some offices apparently occurring due to the relevant officeholders becoming ineligible to hold office as a result of their unfinancial member status. Clarification was sought from the General Secretary of the organisation as to whether the rules regarding the removal of officeholders due to ineligibility had been adhered to, in particular rule 50 which includes, but is not limited to, the requirement for members to be notified of the apparent ineligibility to hold office due to unfinanciality and given the opportunity to respond.² The General Secretary advised the Commission via email on 8 April 2025 that the organisation is currently reviewing the requirements in the rules and implementing processes to ensure the rules are adhered to. The Commission was advised that this process will be completed soon.
- [6] The Commission will be following up with the organisation to confirm the steps that it is taking in relation to this review. I take this opportunity to highlight the requirement of registered organisations to comply with their own rule and emphasise the risks associated with potential rule breaches. The absence of sufficient action by the organisation in respect of such processes, to ensure compliance with rules which can result in the removal of persons from elected office, may leave it open to a challenge from aggrieved members under section 164 and/or 164A of the RO Act.
- [7] For the purposes of this currently requested election, I can conclude, based on the material provided, that these particular offices are vacant.
- [8] I am satisfied that an election for the offices in **Attachment A** and the non-office positions in **Attachment B** is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the AEC.

NATIONAL TERTIARY EDUCATION INDUSTRY UNION - REQUEST FOR ELECTIONS TO BE HELD

TO: The Fair Work Commission.

I, **Damien Cahill**, General Secretary of the National Tertiary Education Industry Union ("the Union"), of 120 Clarendon Street South Melbourne, Victoria, hereby request, pursuant to Section 189 of the Fair Work (Registered Organisations) Act 2009, that the Commissioner approve and arrange for the conduct of a supplementary election required under the rules of the Union and declare as follows:

- 1. Elections are requested for those offices specified in the attached table, Attachment B.
- 2.
- (a) The name of each office (Regulation 138(1)(a)) is specified in the first and second columns of Attachment B.
- (b) The reason for the election (138(1)(b)) is as specified in the fifth column of Attachment B, according to the Key to Election Request which is at the Annexure to Attachment B.
- (c) Where more than one of the offices in respect of which an election is required have the same name (138(1)(c)) the number of such offices is as specified in the third column of Attachment B, headed "No. Required".
- (d) The electorate from which each office is to be elected (138(1)(d)) is as indicated in the fourth column of Attachment B, headed "Elected By", read in conjunction with the Annexure to Attachment B.
- (e) **The voting system to be employed** (138(1)(g)) in the conduct of the election is as indicated in the sixth column of Attachment B read in conjunction with the Annexure to Attachment B.
- (f) The period during which nominations may be called (138(1)(e)) no time is prescribed by the rules.
- 3. These elections may be held, under the rules of the NTEU. The term of office for each position in the attached table is the remainder of the two year term to which the previous incumbent was elected in 2024. Except for the Adeliade University (New Branch this is for the remainder of the two year election period to then fall in line with the normal NTEU election cycle for 2026)

- 4. The date provided for in the rules as the day on which the roll of voters is to be closed (138(1)(f)) is the seventh day before the date determined for the opening of nominations (72.1).
- 5. Attachment C to this statement sets out those positions which are required to be elected under the Rules of the NTEU but which are not considered to be offices as defined in Section 9 of the Fair Work (RO) Act 2009. NTEU requests that the elections for these positions be conducted by the AEC in accordance with s.187 of the Fair Work (RO) Act 2009.
- 6. I have forwarded to the Australian Electoral Commission a copy of this request. It is our hope to advertise nominations from early May 2025. It would therefore be appreciated, if possible, if this request could be approved as soon as possible.
