I, Chris Chant, being the Federal President of the Australian Principals Federation, make the following statement:

- 1. I am authorised to sign this statement containing prescribed information for the Australian Principals Federation.
- 2. The following information is lodged under subsection 189(1) of the Fair Work (Registered Organisations) Act 2009 (the RO Act).
- 3. The elections that are required are set out in the table in Annexure A.
- 4. No rule alterations are pending that will impact the election.
- 5. This statement IS lodged at least 2 months before nominations open for the election(s) in Annexure A.
- 6. If the number of elected representatives is calculated on a formula(s) defined in the rules]:

    - Federal Council- Victorian Branch Representatives: No fewer than 3 with one extra councillor for every 500 financial members of the branch
    - Federal Council- WA Branch Representatives: No fewer than 3 with one extra councillor for every 500 financial members of the branch
  - c. The information for calculating the formula: The Federal Council shall consist of not fewer than three Federal Councillors elected by and from the membership of each branch together with one extra Federal Councillor for each five hundred financial members of each Branch to be elected by and from the members of each Branch.
