s.189—Arrangement for conduct of an election

*Arrangement for conduct of election.*

[1] On 9 April 2025 the Victorian Branch (**the Branch**) of the Australian Hotels Association (**the organisation**) lodged with the Fair Work Commission prescribed information for an election to fill the following offices, due to insufficient nominations received in a previous election (**E2024/208**):

**Councillors from the following Divisions:**

Southern Metropolitan	(1)
North-Eastern Metropolitan	(1)
Accommodation Hotels Division	(2)

Executive Board Members from the Accommodation Hotels Division	(2)

[2] Branch rule 17 indicates that the two offices of Executive Board Members from the Accommodation Hotels Division referred to above, are elected collegiately by and from the Branch Council Members of the Accommodation Hotels Division.

[3] In written correspondence dated 1 May 2025, the Branch indicates that they “*currently do not have any elected Council Members from the Accommodation Hotels Division, and as such, there will be no collegiate available for nominations...(x2) of Executive member – Accommodation Hotels Division*” Accordingly, the Branch seeks that the election for the above Council Members, and in particular those Councillors from the Accommodation Hotels Division, be conducted first, before a further election for the Executive Board Members from the Accommodation Hotels Division is conducted.

[4] Given the apparent absence of current Councillors from the Accommodation Hotel Division, I therefore request that the Australian Electoral Commission (**AEC**) conduct the election for the abovenamed offices in two stages, the first stage being for the Council Members and the second stage being for the Executive Board Members from the Accommodation Hotels Division.

[5] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the AEC.
