Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Independent Education Union of Australia (E2025/95)

Arrangement for conduct of election.

[1] On 8 May 2025 the Victoria Tasmania Branch (**Branch**) of the Independent Education Union of Australia (**IEUA**) lodged with the Fair Work Commission (**Commission**) prescribed information for an election to fill the following offices for a new term of office:

- [2] The Branch had lodged prescribed information on 19 March 2025 in anticipation of its scheduled quadrennial elections. At the time of lodgement, the Branch indicated that proposed rule alterations had been lodged with the Commission on 7 February 2025, which would affect the offices to be elected at the upcoming scheduled election. After consultation with the Commission, the rule alterations were withdrawn on 28 March 2025, with amended rule alterations being lodged on 15 April 2025. These amended rule alterations included the removal of some offices, which would affect the upcoming election.
- [3] The Branch advised of its preference that the rule alterations be certified prior to the conduct of the election, noting its concerns about conducting an election while rule alterations are on foot. The risks associated with this outcome are demonstrated in the decision of *Sara*, in the matter of an inquiry into the election for offices in the Australian Salaried Medical Officers Federation¹. In this instance, an officer of that organisation was obliged to seek orders from the Federal Court to prevent two concurrent elections (including for a number of recently abolished or replaced offices) in circumstances where an election had commenced under the 'old' rules which were entirely replaced by 'new' rules prior to the conclusion of that election.
- [4] Following consultation with Commission staff, the Branch withdrew its prescribed information pending the certification of the lodged rule alterations. At that time, the Branch undertook to lodge the updated prescribed information, in accordance with the new rulebook, as soon as possible after the rule alterations were certified.
- [5] On 7 May 2025 the rule alterations were certified by the Commission² and on 8 May 2025, the Branch lodged updated prescribed information.
- [6] Regulation 138(3) of the *Fair Work (Registered Organisations) Regulations* 2009 requires prescribed information to be lodged at least 2 months before nominations are due to open. While the Branch rules do not specify a date for nominations to open (and the dates outlined in the prescribed information are simply the Branch's preference), IEUA rule 17(h) provides that elections must be completed by 31 October.³ I am satisfied that, despite the delay due to rule alterations, the prescribed information has been lodged with sufficient time for the elections to likely be completed by 31 October 2025).
- [7] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the IEUA and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
