Nominations OPEN	To be determined by the Returning Officer in accordance with Sub-rule 12.5(a). Please note sub-rule 12.5(c) – 'The Returning Officer shall call for nominations and conduct the election in such a way that the ballot shall be counted and declared by the Friday preceding the Annual Convention'. The AFAP's 2024 Annual Convention will be held on Friday 18 October 2024 and the date of the preceding Friday is 11 October 2024.
Nominations CLOSE	Sub-rule 12.6(a) 'Nominations for the position of Federal Officers shall be declared open for a period of 21 days'
Roll of Voters cut off date	Sub-rule 12.7(c) – 'A roll of voters shall be prepared by the Returning Officer which shall be updated so as to include all financial members of the Federation on the fourteenth day prior to the opening of nominations'.
