- [2] Under the rules of the organisation, there are a number of offices (particularly those where representatives are elected from each Branch to another body) in which the Branch's entitlement is calculated based on membership as at 30 June in the current year. As part of its prescribed information, the organisation has given an undertaking to do this. It has separately indicated that a copy of that notification to the AEC will be provided to this Commission.
- [4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations)* Act 2009, I am making arrangements for the conduct of the election by the AEC.

- I, Nicole Calnan being the Deputy Federal Secretary of the Australian Education Union make the following statement:
- 1. I am authorised to sign this statement containing prescribed information for elections due to be held in all Branches of the Australian Education Union.
- 2. The following information is lodged under subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009 (the RO Act).
- 3. The elections that are required are set out in the table in Annexure A.
- 4. No rule alterations are pending that will impact the elections.
- 5. This statement **IS** lodged at least 2 months before nominations open for the elections in Annexure Α.
- 6. The rule numbers which specify the formulas are Rule 24(3A), Rule 25, Rule 47(3), Rule 47A and various Branch Rules concerning the minimum representation of women in connection with any ballots that are necessary for the election of Federal Conference Delegates from the General Division and the National TAFE Council.
- 7. As per Rule 24 (4), Financial membership numbers for the General Division and TAFE Division as at 30 June 2025 will determine the number of positions for each office for each branch.
- 8. As per Rule 24 (4A), in the case of the Aboriginal and Torres Strait Islander delegates the number of Aboriginal and Torres Strait Islander financial members in each branch as at 30 June 2025 will be the determinate.

- 9. I will supply the AEC with the number of financial members as at 30 June 2025 and the number of positions for each office for each branch as soon as they have been collected.
- 10. As per Rule 30 (2), "Subject to the next sub-rule, the elections shall be conducted in accordance with a timetable which permits the declaration of the election on or before 31 October prior to the date on which the Federal Delegates assume office."
- 11. Federal Rule 73, 74, 75 and 76 are the relevant Rules for the election of the Aboriginal and Torres Islander Education Committees (TAFE and General Divisions), National Principals' Committee and National Early Childhood Committee members. The declaration of these elections must be on or before 31 October prior to the date the member takes office.
