Arrangement for conduct of election.

[1] On 19 June 2025 the Australian Salaried Medical Officers Federation (the **organisation**) lodged with the Fair Work Commission prescribed information for an election to fill a casual vacancy in the following offices for the remainder of the term:

[2] The casual vacancy for the office of Branch Vice-President for the Australian Capital Territory Branch arose because the incumbent officer was recently elected as Branch President in election **E2025/22** and, under the organisation's rules, cannot hold both offices.

[3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.




