Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Australian Education Union (E2025/56)

Arrangement for conduct of election.

- [1] On 21 May 2025 the Northern Territory Branch (the **Branch**) of the Australian Education Union lodged with the Fair Work Commission (the **Commission**) prescribed information for an election. At the time of lodgement, the Branch advised that rule alterations affecting the election had been passed by Branch Conference resolution but had not been lodged with the Commission. Among the rule alterations sought was a change to the regions from which Executive Councillors are elected.
- [2] Commission staff advised the Branch to promptly lodge an application under section 159 (alteration of other rules of organisation) of the *Fair Work (Registered Organisations) Act* 2009 (the **Act**), so that the Commission could consider and (if appropriate) certify the proposed alterations so that the amended rules would apply to this election if that was the Branch's intention.
- [3] The section 159 application for rule alteration was lodged by the Branch on 31 May 2025 (matter number **R2025/84**). Further information was provided by the Branch regarding the application, and the rule alterations were certified on 11 June 2025.¹
- [4] On 12 and 16 June 2025, the Branch lodged amended prescribed information in relation to this election, which reflected the new regions for the Executive Councillors that had been the subject of the rule alterations in **R2025/84**. The amended prescribed information accordingly seeks to fill the following offices for a new term of office:
