*Fair Work (Registered Organisations) Act 2009* s.189—Arrangement for conduct of an election

Arrangement for conduct of election.

[1] On 20 June 2025 the Australian Hotels Association (AHA) lodged with the Fair Work Commission prescribed information for an election to fill the following offices for a new term of office:

Secretary/Treasurer	(1)

[2] These offices are elected by and from members of the AHA National Board. Under the AHA rules, specifically rule 14(b), the election is held at first Board meeting following the election of National Board Members. AHA rules 15 and 16 set out the election procedures.<sup>1</sup>

[3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
