

# DECISION

*Fair Work (Registered Organisations) Act 2009* s.189—Arrangement for conduct of an election

**Independent Education Union of Australia** (E2025/55)

Arrangement for conduct of election.

[1] On 18 June 2025 the Queensland and Northern Territory Branch (the **Branch**) of the Independent Education Union of Australia (**organisation**) lodged with the Fair Work Commission prescribed information for an election to fill the following offices for a new term of office:

### Whether prescribed information was lodged on time

[2] Section 189(2) of the *Fair Work (Registered Organisations) Act 2009* (**RO Act**) requires that organisations and branches must lodge prescribed information before a 'prescribed day'. Regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009* defines the prescribed day as the day occurring two months before the date nominations open.

[3] The organisation's rules do not directly provide a specific day or week when nominations open. Instead, rule 17 of the organisation's Federal rules provides an election timetable which details minimum and maximum periods for which nominations must remain open and how soon a ballot (if required) must be held after the date nominations close. The nature of this timetable therefore allows for some variation of the relevant dates by a few weeks.

[4] I have set out below the election timetable as provided in rule 17, doing so in reverse order so as to calculate the projected date nominations are due to open.

- The election must be completed by 31 October of an election year<sup>1</sup>.
- Where there is a contested election, such that more nominations are received than there are offices to fill, a ballot is required.
- The ballot must remain open for 22 days<sup>2</sup>.

- Therefore the latest date for the ballot to open is 9 October.
- The maximum period between the date nominations close and the date the ballot opens (if a ballot is required) is six (6) weeks<sup>3</sup>.
- Therefore the latest date for nominations to close is 28 August.
- Nominations are required to remain open for at least 21 days<sup>4</sup>, making the 7 August the latest date for nominations to open.
- Accordingly, if nominations were to open on 7 August 2025, the prescribed day to lodge prescribed information would be 7 June 2025.

[5] The prescribed information for this election was lodged on 18 June 2025 and the information states that the open and close dates for nominations are 'to be determined by the returning officer'.

[6] The statement and declaration accompanying the prescribed information declares that the information has been lodged at least two months before the date nominations open for this election. However, this statement is only true if the Returning Officer determines the date that nominations open is a date after 18 August 2025. If the Returning Officer determines that nominations open on or before 18 August 2025, then the Branch will not have complied with the requirements of section 189(2) of the RO Act.

[7] As I mentioned previously, the election timetable allows for some variation of the opening and closing dates to call for nominations and to hold a ballot. I strongly encourage the Branch, to lodge its prescribed information on a <u>date before 7 June</u> in an election year for these offices in order to avoid any question or ambiguity about whether the Branch has met its obligations under section 189(2) of the RO Act.

### Proportion of offices on Federal Council to be filled by women

**[8]** Rule 8(c)(ii) of the organisation's rules, in addition to setting out the formula for determining the number of Federal Council Delegates that each Branch is entitled to, also requires that:

... where a Branch has more than 50% women financial members, not less than 50% of the offices on Federal Council for the Branch delegation outlined in Rule 8(c)(i) will be filled by women. *At each triennial election, the Branch Secretary will provide to the Returning Officer a certificate showing the percentage of women financial members at 31 December in the preceding year*. This sub rule shall not apply to the Queensland and Northern Territory Branch where that Branch has 5000 members or fewer. [Emphasis added]

**[9]** On the available information, the Branch has more than 5,000 members, therefore rule 8(c)(ii) applies to this election if more than 50 percent of the financial members of the Branch are women.

**[10]** The prescribed information does not appear to include information about the proportion of women in the Branch to address rule 8(c)(ii). I remind the Branch of the requirement to provide this information to the Australian Electoral Commission (**AEC**), which is responsible for conducting this election.
