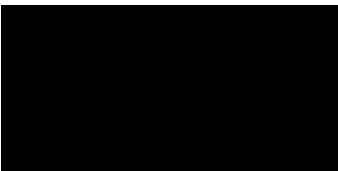
**Section 271 application for certificate of exemption from the requirements of Part 3 of Chapter 8 of the

**RE: APPLICATION FOR EXEMPTION PURSUANT TO SECTION 271 OF THE FAIR WORK  
(REGISTERED ORGANISATIONS) ACT 2009**

The Local Government, Racing and Cemeteries Employees Union, makes application pursuant to Section 271 of the Act and Regulation 165 of the Regulations for exemption from financial reporting for the financial reporting period ending 30 June 2025 for the following reasons:

- A) The reporting unit has not expended economic resources, nor has it incurred any financial obligations to conduct its activities; and
- B) The union's state counterpart organisation known as the Local Geovernment, Racing and Cemeteries Employees Union (WA) has expended all necessary economic resources and incurred all financial obligations so that the Federal Reporting Unit could conduct its activities for the reporting period ending 30 June 2025.
- C) The above conditions in A) and B) have applied in respect of previous reporting periods.
- D) The reporting unit does not employ staff, maintain a bank account, hold money in cash, receive membership fees or any other income, and does not hold or have any corporate credit cards issued in its name.
