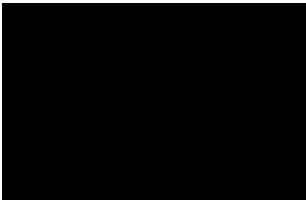
**Section 271 application for certificate of exemption from the requirements of Part 3 of Chapter 8 of the


