Arrangement for conduct of election.

[1] On 24 July 2025 the Breweries and Bottleyards Employees' Industrial Union of Workers of Western Australia (the **organisation**) lodged with the Fair Work Commission prescribed information for an election to fill the following offices for a new term of office:

Vice President	(1)
Trustees	(2)
Ordinary Member of the Committee of Management	(1)

[2] Rule 10 of the organisation's rules, in particular sub-rules 10(4) and 10(5), provide for the election of officers for two-year terms, on a rotating basis, with half of the offices therefore due for election in any given year (i.e. next year's election will be for the other offices, namely President, one Trustee and two ordinary committee members).

[3] The offices of Secretary and Treasurer are an exception to the above rotational election cycle, with the elections for those two offices occurring every four (4) years in accordance with the organisation's rules 13(4) and 14(4). Those offices will also be due for election next year.

[4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.


