Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Arrangement for conduct of election.

[1] On 31 July 2025, the New South Wales Branch (the Branch) of the Australian Hotels Association (the organisation) lodged with the Fair Work Commission prescribed information for an election to fill the following offices for a new term of office:

[2] In assessing the prescribed information for this election, Commission staff were unable to identify within the Branch and/or organisation rules, the basis for determining the number of General Division Sub-Branch Delegates. In response to the Commission's enquiry on this point, the Branch advised that it was unsure of the basis of determining the number of General Division Sub-Branch Delegates but that the number had remained unchanged for the previous decade. I note that in the previous scheduled Branch election in (E2023/129)<sup>1</sup> the number of Sub-Branch Delegates was the same as that requested in the prescribed information for this election.

- Rule 18.1 of the Branch rules<sup>2</sup> provide that the Branch shall be divided into various Divisions described as the General Division, the Accommodation Division, the Off-Licence Division, the Motels Division, the Security Division and the Hotel Freehold Owners Division. The Branch advised that there are currently no members in the Off-Licence, Motels, Security and Hotel Freehold Owners Divisions, with all Branch members sitting within either the General Division or the Accommodation Division
- [4] Rule 18.2 provides that the General Division Sub-Branches 'shall have such territorial boundaries as Council may determine' The Sub-Branch territorial boundaries as determined by the Branch Council and the accompanying Sub-Branch Delegate representatives are set out in **Annexure A** to this decision.
- [5] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
