Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Australian Federated Union of Locomotive Employees (E2025/74)

Arrangement for conduct of election.

[1] On 2 September 2025 the Australian Federated Union of Locomotive Employees (the **organisation**) lodged with the Fair Work Commission (the **Commission**) prescribed information for an election to fill the following offices for a new term of office:

[6] A copy of the request for the Australian Electoral Commission (AEC) to conduct the election for the non-office positions has been sent to the AEC.

- [7] The organisation did not lodge the prescribed information before the prescribed day as required by regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009*. The prescribed information should have been lodged by mid-August 2025.
- [8] In correspondence dated 4 August 2025, the State Secretary of the organisation declared that the delay was due to "rule changes pending with the Commission (R2025/110) which includes the creation of an additional two elected positions". Furthermore, the State Secretary provided an undertaking to "lodge the prescribed information as soon as the rule changes are certified"
- [9] As noted in this decision, the certification of rule alteration matter R2025/110 occurred on 1 September 2025 and the lodgement of prescribed information for this election occurred one day later on 2 September 2025. I note the positive steps taken promptly by the organisation to lodge their prescribed information immediately after certification of the rules matter and on this occasion I allow, under section 189(2) of the Act, a later day for lodgement.
- [10] I am satisfied that an election for the abovenamed **office and non-office positions** is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the AEC.
