Arrangement for conduct of election.

[1] On 15 September 2025, the Victoria Tasmania Branch of the Independent Education Union of Australia lodged with the Fair Work Commission prescribed information for an election to fill a casual vacancy for the remainder of the term and to fill vacancies due insufficient nominations received in the Branch's most recent scheduled election (E2025/95):


