Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Australian Trainers' Association (E2025/138)

Arrangement for conduct of election.

[1] On 22 August 2025 the Australian Trainers' Association (the **organisation**) lodged with the Fair Work Commission (the **Commission**) prescribed information for an election to fill the following offices, due to insufficient nominations received in a previous election (**E2025/50**):

Federal Executive

Executive Officer from South Australia Branch	(1)
Executive Officer from Queensland Branch	(1)
State Branches	
South Australia Branch Committee Members	(2)
Tasmania Branch Committee Members	(4)
Queensland Branch Committee Members	(5)

- [2] In the previous election E2025/50, no nominations were received to fill some other offices, namely the Executive Officer from Western Australia and the Western Australia Branch Committee. The prescribed information did not request to fill those vacant offices, and the organisation has previously advised the Commission that it intends to abolish that Branch.
- On the same day, the organisation also lodged prescribed information for an election to fill a casual vacancy in the following office for the remainder of the term:

Federal Executive

Executive Officer from Queensland Branch (1)

[4] Rule 9(a) of the organisation's rules provides that there shall be two Executive Officers from each Branch and that the election of each Executive Officer from a branch will occur on a rotational basis – that is, one Executive Officer from a branch is elected in an odd-numbered year and the second Executive Officer from the same branch is elected in an even-numbered

year. Rule 15 provides that the term of office for Executive Officers is two years from the date of their election. The term of office for this casually vacant office in the Queensland Branch is due to expire in 2026.

[5] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
